DAVE HOWE MEMORIAL SCHOLARSHIP

The Dave Howe Memorial Scholarship was created to honor Dave Howe's memory and his passion for youth ski racing and his commitment to CSAT. Through sun, rain, and snow Dave's photography tirelessly memorialized CSAT's racers and team activities.

Eligibility Requirements:

1. Must show financial hardship.
2. Must be competing as U14/U12 or older at the start of the coming competition season.
3. Must have competed for a minimum of two years with CSAT.
4. Development Team members are not eligible.

Financial Hardship Standard:

- Applicants are required to submit as part of their scholarship application a breakdown of their income sources and non-discretionary expenses including all ski racing related costs, i.e. program fees/coaching, equipment, race travel, etc. to evaluate if a financial hardship is present.
- Financial hardship is defined as a need resulting from deficient income to meet non discretionary expenses associated with competing in ski racing or freeskiing. Please identify funds needed for training, coaching, equipment and / or event participation, including related travel expenses, camps that cannot be satisfied through other sources.

1. Completed application w/parent signature
One (1) personal cover letter to address. - Your overall approach, philosophy towards skiing and future goals in skiing.
2. CSAT Value Statement – In a one (1) page essay tell a story from your ski team or competition experience that highlights your commitment to your goals and demonstrates one of CSAT's values.
3. Copy of IRS 1040 or Short Form, breakdown of non-discretionary spending, and brief statement of need.
4. Brief statement describing future educational goals
5. Most current academic grades
