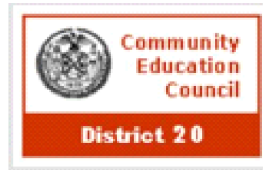

II. Old Business - approval of the July 2022 Calendar Meeting minutes

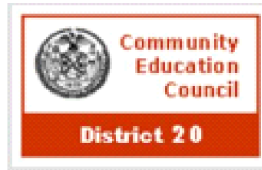
II. New Business

- a. Office of District Planning** - Jamie Dollinger and Perry Stein from the ODP attended in order to hold a preliminary discussion in advance of the official data consultation meeting to be held later in the year. Stein shared a presentation on ODP's role with CEC's, particularly on rezoning changes. He mentioned a few issues for District 20 including the potential programming changes around the opening of new capacity in 2024, as well as continued efforts to secure new capacity. Members shared their individual planning concerns which were as follows:
- a. Stowe - expand G&T, new capacity in eastern part of District, study average commute times by school
 - b. Chan - high number of Asian families with low MS or HS placement, safety / security of students in schools and neighborhood
 - c. Brugueras - G&T expansion, neighborhood safety around new ES site on 3rd avenue
 - d. Xie - safety and distance of traveling to middle schools, better academic screened programs
 - e. Amin - number of students in classrooms, lack of quality afterschool programs compared to private schools,
 - f. Isufi - safety in and around schools, improve Summer Rising
 - g. Rozenblatt - improve / increase academically rigorous programs, school and neighborhood safety
 - h. Jiang - safety on transportation, quality of education
