



Junior Coders Club: General Terms and Conditions for Online Coding Classes

Welcome to Junior Coders Club!

Please read the following terms and conditions carefully **BEFORE** enrolling your child in our online classes.

1. No Photography & Videography:

- By enrolling my child in the Junior Coders Club, I understand that my child is not permitted to take any photos or videos during class sessions, including screenshots or screen recordings of the online class. This policy is in place to ensure the privacy and safety of all participants.

2. Confidentiality and Privacy:

- By enrolling my child in the Junior Coders Club, I understand that the class content, interactions, and activities are intended for the enrolled participants only and that sharing or capturing class materials without permission is strictly prohibited.

3. Supervision and Compliance:

- By enrolling my child in the Junior Coders Club, I agree to ensure that my child follows the guideline and refrains from any unauthorized photography, videography, or recording during class. I will monitor them during the class and be the sole responsible person if anything goes wrong.

4. Classes are Pre-paid:

- By enrolling my child in the Junior Coders Club, I agree to make in-advance payment for at least the upcoming month. Thank you for your cooperation!
- Continued enrollment is confirmed once we receive the completed registration form and payment. Please note that if payment is more than a week overdue, we may not be able to enroll your child in the running month's cycle. Thank you for understanding.

5. Enrollment and Participation:

- By enrolling my child in the Junior Coders Club, I agree to the terms and conditions mentioned here.
- Enrollment is confirmed upon receipt of the completed registration form and payment.

6. Class Requirements:

- Each student must have access to a desktop or laptop computer with a reliable internet connection and be able to hear and speak to the class. The students must frequently share their screen to the entire class in their learning process. I will make sure that my child will not share any sensitive information to the class. If my child showed our (families) sensitive information, I will not claim to the Junior Coders Club LLC any legal issues involved with it.
- A quiet and conducive learning environment is necessary for my child to focus during online classes and I am responsible for providing that and I will monitor the child during the entire class time.

7. Parental Consent and Monitoring:

- As a parent or legal guardian I must consent to my child participating in online classes and agree to monitor my child's activities during these sessions.
- I must ensure my children adhere to the class schedule and participate actively.
- I am responsible for ensuring my
- the child is logged into the online class on time.
- If a child is absent or late, I must ensure that a communication occurs before, during, or after the class.
- Parents will be notified if a child did not attend the class or if there are behavioral issues. Parents must take appropriate action to address and correct their child's classroom behavior.
- The Junior Coders Club's teachers will inform me if my child did not do class or after class activities such as quizzes, musters, projects, etc and I must be responsible for my child doing those in a timely manner.

8. Conduct and Behavior:

- Students are expected to behave respectfully and responsibly during online classes.
- Disruptive behavior will not be tolerated and may result in removal from the class in extreme cases.

9. Class Schedule and Attendance:

- Classes will be held according to the schedule provided during enrollment.
- Regular attendance is required for the successful completion of the course. I must inform the teacher in advance if my child will be absent.
- If a class is canceled, communication is made early in advance to both the students and their parents.

10. Cancellation and Refund Policy:

- Cancellations made more than 7 days before the start of the course month-to-month will receive a full refund.
- Refunds will only be issued for cancellations made 7 days before the start of the next payment cycle or for missed classes. Please contact us in case you did not fall under this condition and still need to cancel the class after a payment is made.

11. Medical Absence:

- If your child is unable to attend class due to medical reasons, please contact us and we will provide you with a form to fill out that will provide class credit for medical absence. You must also provide necessary documents. We will review and verify the request before issuing a credit class.

12. Content and Materials:

- All course materials provided by Junior Coders Club are for educational purposes only and remain the intellectual property of Junior Coders Club.
- Unauthorized distribution or reproduction of course materials is prohibited. The Junior Coders Club can legally bind you in case if such recording or distribution is detected.

13. Electronic Signature Consent:

- By enrolling in our courses, I consent to the use of electronic signatures as valid and binding as actual in-person paper and pen or thumb print signatures.

14. Privacy and Data Protection:

- Junior Coders Club is committed to protecting your privacy. Personal information provided during registration will be used solely for class-related purposes and will not be shared with third parties by any means.

15. Consent for communication:

- By providing your phone number and/or email address during registration, you agree to receive communications from the Junior Coders Club (JCC). This may include class reminders, payment notifications, and information about upcoming events. Rest assured, JCC will never sell your information to third parties for any reason. If a phone number needs to be changed, I must let the Junior Coders club know as soon as possible.

16. Class Dissolvment and Merger:

- Junior Coders Club reserves the right to dissolve and merge it to a different appropriate class if the number of students drop below 10. The parents have the option to opt-out if the decision made is not in favor of the student's availability.
- JCC can also help make accommodations if the student's availability has changed. During this I understand that I will play an important role in understanding and co-operate the transition.

17. Referral Bonus: see detailed info at section ***Referral Bonus Program Details***

Referral Bonus Program Details:

To qualify for a referral bonus, the people you refer must complete the registration form and mention your name as the referrer in the appropriate field(**Refer by; if any**). We can only provide the referral bonus if this information is included.

How the Referral Bonus Works:

- **Eligibility:** You will be eligible for the referral bonus after successfully referring **4 students** who sign up and stay enrolled beyond the trial period.
- **Trial Period:** All four students must remain after the trial period for you to qualify for the bonus.
- **Bonus Structure:**
 - For each student who stays for **1 month** after the trial period, you will receive **\$10**.
 - If you refer a **5th student** after the 4th student, you will receive an **additional \$10** bonus and so on.
 - If a student leaves after their **first paid month**, you will **not lose** your bonus for that student.

Important Notes:

- If you refer only two students and they stay after the trial, you will **not** be eligible for the bonus.
- All four referred students must stay for the required duration in order to receive the bonus.
