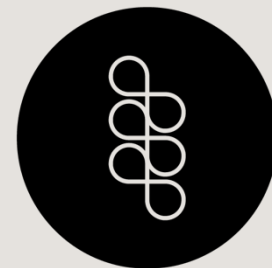


Notification of Address Change



As Soon As Possible

Utilities	Fill out this Utility Transfer Application .
Financial Institutions	Call your financial institution or do it from your online account.
O.A.S Pension	Call 1-800-277-9914 and mail your documents to the nearest Service Canada Centre or visit that location directly.
TV, Internet & Phone	From your online account or by phone.
Children(s) School/Daycare/Activities	By phone or in person at the old and new school.

One to Two Weeks Before Moving

Alberta Pensions Services Corporations	Log into your My Service Canada Account and select “Update my profile” on your dashboard, then “Address”. Contact the LAPP at 1-877-649-5299 Contact the PSPP at 1-877-453-1777 Contact the SFPP at 1-877-809-7377 Contact the MEPP at 1-877-889-6377
Employment Insurance	Using your My Service Canada Account . By calling 1-800-206-7218. In person at a Service Canada Centre near you.
Mobile Phone Provider	On your online account or by calling your phone provider.
Canada Savings Bond	Through the online service or by phone at 1-877-899-3599.
Alberta Treasury Board and Finance	By phone at 1-780-427-3044.
Boat Permits	Via the Pleasure Craft Electronic Licensing System (PCELS).
Alberta Student Aid	Online through your Student Aid Account .

Two Weeks After Moving

Service Alberta, Vehicle Registration, and Driver’s Licence	By visiting a registry agent . You will need to provide supporting documentation, which includes both your physical and mailing address within Alberta. More information on changing your address with Service Alberta.
Alberta Health Services	Completing a Notice of Change Form and bringing it to an authorized registry agent location . By dialing 310-000 then 780-427-1432.

<i>Canadian Firearms Program of the RCMP</i>	Using your GCKey secure account . By calling 1-800-731-4000.

Before or After Moving	
<i>Streaming Services</i>	Through your online account.
<i>Canada Revenue Agency</i>	Through your online account . By contacting the CRA at 1-800-959-7383. You will also be able to change your address during the annual tax return season.
<i>Hunting and Fishing License</i>	Through your online account . Visit your local Issuer and complete a WIN Application form to update any new information (Section A). Call the Active Network Alberta RELM Help Desk toll-free at 1-888-944-5494
<i>Employer</i>	Notify the HR department.
<i>Pharmacist</i>	In person or by phone. It is important to talk to your pharmacist to transfer your file to a new pharmacy if required. Please note that some prescriptions are not transferable, and you might need a new prescription
<i>Dentist</i>	Mention it to the dentist or receptionist during your next call or visit.
<i>Car Manufacturer and Dealership</i>	Online, by phone, or on your next visit.
<i>Elections Alberta</i>	Online through the voterlink portal. Call elections Alberta at 780-427-7191. When updating your information with voterlink, you will need to have your Alberta's Driver's Licence or an Alberta ID on hand.
<i>Elections Canada</i>	Through the Elections Canada website. If you cannot complete the form online, you can print it and send it directly to Elections Canada.
