We ask that all readers approach this document with the seriousness and respect the subject matter demands. This is not intended to provoke unnecessary conflict, gossip or dispute, but rather to hold Alton accountable, promote awareness within our community, and safeguard community members from future harm.

Through our documentation of these events, we aim to create a foundation for accountability and to contribute to the ongoing effort to ensure a safe and respectful community. Your attention to this matter is deeply valued.

9/21 N-Word Usage

Intro

I've decided to begin this document by outlining the incident of Alton's usage of the n-word, which I personally found to be incredibly ignorant and disrespectful.

Context


The incident occurred on the night of September 21st, which was Sunday of AFC, a furry convention Alton, few others and myself were roommates for. We spent the early evening in our room hanging out and chatting, an overall very low-energy gathering with no alcohol involved.

Across the hallway, there was a room anyone could walk in to chill and relax, with a friend of mine playing ambient music for the audience there. I had asked Alton if he wanted to perform together at said room, and he agreed. We got to the room, but for around 30 minutes, Alton took a detour to the convention center to walk with a friend to pick up something they had forgotten. When those thirty minutes had passed, we performed together in the room.

Once we had finished, I was feeling cathartic and posted a selfie with text on my close-friends Instagram. He immediately responded by calling me a racial slur. Alton responded to the story almost immediately after I posted it and was with me in the room when he did. Both my Instagram story and his response can be found below.





The Following Morning

At that moment, upon seeing his message, I was bewildered and blocked it out of my head, deciding to make it tomorrow's problem. I had heard from a few others that Alton has behaved like this in the past, so I was not particularly surprised, but it was different for me observing it firsthand. After we left the room, Alton went to a room party while I spent the night with a few other friends back in my own room. Alton returned later that night and I did not treat him differently, and we did not interact any further when he left the following Monday morning.


My Course of Action

Despite being in disbelief at the situation, I went about my life normally for the next three days, but it eventually bothered me so much that I had decided to reach out to few (2-3) people in the early hours of Thursday, 9/25/25. Casper, one of the people I messaged regarding the situation, decided to take immediate action and reach out to Alton and address the situation directly. Screenshots of this interaction (9/25/25) are below, with a few annotations made by me that I will address. Note that message timestamps pertain to when Casper forwarded their interaction to me and do not reflect those of their real-time conversation.



Alton's Response

Alton reached out to me promptly after his conversation with Casper (above) and asked if he could speak with me over the phone. I declined, and our final interaction to this day (9/30/25) is as follows.



Here's an explanation for my four back-to-back messages, as they seem out-of-nowhere. I had heard from close friends in the past that he had plainly said the n-word, not only in additional times in text, but also in voice calls in his personal Discord server (to be addressed in the next section). I firmly believed that he would not address this issue given his past offenses which led me to push further and send the messages in question.

I will not give a personal opinion on the quality of his response at this time.

Additional Note

I contacted Taiga regarding his statement with the goal of having this information trickle down to CSUF's furry student organization's leadership with which Taiga is associated. For context, Alton was the president of a furry-fandom based club at CSUF named Cal State


Furryton. I was resolute that Alton was in no circumstance a good fit to be the president of Cal State Furryton. The club board would soon remove Alton after hearing of this incident.

"It was around August 11th that I joined the server voice chat, and I remember Alton and Borkus being there specifically. They were discussing their results and taking a test that was sent to the server called the "Race Purity Test". This test was, according to the website, a "racism assessment based on one's experiences with different races throughout life. The higher your score, the more racist you are."

One of Alton's associates in his Private Discord server was reading questions off of the test, and was saying the derogatory slurs associated with the questions. When his associate got to around the middle of the question list, three questions asked if the person taking the test had said the n-word (with the hard r) before, either IRL or Online. I recall someone mentioning something in relation to the question, and Alton responded with, "**Have you ever called someone a sand n****r?**". The entire Discord voice chat got quiet for a while, but I do think everyone else in there brushed it off.

Persistent Racism

Sustained Discriminatory Behavior

As shown by the previous testimonies which highlight the other usages of racial slurs alongside racist commentary, Alton's usage of the n-word was not just a slip-up, but just another stop in the pattern of racism and discriminatory behavior. He had made several promises to his friends that he would improve on himself, which is expanded upon in other tabs of this document. Despite these promises, however, the following screenshots show that he continues in his offensive and racist behaviors. As the following sections will show, he hid much of his discriminatory nature behind private servers, alternative accounts, and offline encounters.


Alton's promises to improve himself are detailed in the [Intrusive Calling tab](#), which describes the events of a phone call on July 12th, 2025 and into the 13th. The phone call's primary objective was to earnestly have a heart-to-heart with Alton to express grievances and give him a way to improve, as he was deeply perturbed that people were not interested in being around him at this point in time. Further details of this event, including timestamps, are within the aforementioned tab. This is important to note, as part of the conversation involved discussion of his racist friends, as one of the reasons why people were uncomfortable with Alton's presence at events was because of the company he keeps.

Enabling Environment

Discussion of his friend group is an important part of this document as the people inside of his group include known racists.





A primary standout includes Borkus, who holds extremely racist beliefs and frequently uses racial slurs.

On September 10th, 2025, Alton was personally confronted by a concerned individual. The Telegram screenshot (right) is the conversation which made the individual concerned, while the Discord screenshot (left) is the conversation that followed.






A noteworthy aspect of the above Discord conversation is the fact that Alton stated that the discriminatory comments were simply jokes and “purely humor”.

As referenced [earlier](#), on September 21st, Alton sent Aspy a message in which he used a racial slur in a demeaning way. The screenshots below show Alton’s responses to the situation. They also include comments from his friend group, some of whom make light of the situation.





General Misconduct

Misogyny Toward Trans Women


Alton was oddly comfortable with directing misogyny towards trans women as jokes. He would often join voice calls, then tell me to “get back in the kitchen”, “fetch me another beer b***h”, or to “go make me a sandwich” completely unprompted. Notably, I crashed my car in October, to which he responded with “Estrogen is already working, I see. Your driving stat is destroyed.” While this instance was framed as a joke, other instances were just him blurting out some misogynistic “joke” with no actual punchline.

Problematic Behavior / Misconduct

During the AFC, a handful of us were intending to join him in his room. Once he had realized that his roommate was sleeping, he left us in the hallway for a few minutes only to come back out of the room with a Buzzballz Biggies to give others sips of, he mainly drank the significant amount remaining.

After this, we started to walk to grab food at In-N-Out. On our way there, he had blocked a truck in a crosswalk, to which one of us had to pull him out of the way.

Once we had started walking down Convention Center way, he proceeded to walk ahead of us and start smacking the car's side view mirrors. While he didn't seem to cause any apparent damage, we were concerned since he was smacking the mirrors hard enough to be a cause for concern. By the time he had smacked a handful of mirrors, we were yelling at him to stop. He started to push on an SUV's mirror, which made an audible, plastic-creaking/cracking sound. Multiple people had to yell at him and catch up to him to prevent him from causing damage, since he started pushing on the mirror as well, since it wasn't a folding-style mirror.

Towards the end of the walk to In-N-Out, he nearly walked with full confidence into the hot/fresh asphalt, which required him to be stopped and guided through the active construction zone at the intersection we had to cross. (edited)

Anonymous account of drunken behavior during AFC

Alton often joined voice calls during work. During the call, he began speaking to his coworker in Spanish. While I don't recall exactly what he said, I did hear him say my name, then "ella es torta" or something along those lines, which immediately tipped me off to the fact that he was talking behind my back. Mia and another friend who spoke Spanish confirmed to me that he was saying rude things behind my back, mostly commenting on my weight. When I confronted him, he tried to play it off, so I left the call. He then came to me, trying to apologize. During the conversation, he tried to say he was saying these things because he "found me beautiful" despite him and his coworker audibly laughing about it.

Harassment

Harassment

The following tabs are a few accounts of harassment by Alton. These provide additional context into his bullying and misconduct.

Intrusive Calling

Context

On June 11th, 2025, a Discord server was established for local friends to coordinate spontaneous meetups and social gatherings. Since Alton was in Europe at the time, he was not initially included. As time passed, several members of the group grew increasingly hesitant about extending him an invitation, citing concerns regarding both the individuals he associated with and the nature of some of his interactions within the friend group.

One member in the Discord server had a birthday party in July, and local residents in the area were invited. Alton was excluded by virtue of him not being in the server, even though he still hung out with members of the server from time to time. His exclusion was not intended to make him feel bad, but rather to make sure the majority of attendees were comfortable. He found out about this though, and began contacting attendees (through phone call) to confront them about why they were uncomfortable with his presence.

Additionally, “girlies” is used in an unserious manner, feminine-presenting people were not the only people uncomfortable with Alton’s behavior.

Alton's Reaction to his Exclusion

Alton became aware that several individuals who attended the birthday party had felt uncomfortable in his presence. In the days following the event, he began contacting multiple attendees to inquire about the reasons for their discomfort. This approach, however, caused significant distress and anxiety among those he reached out to.

Our Response

On July 12, 2025, a small group of individuals chose to approach Alton directly in an effort to address the situation, clarify the concerns, and provide him with an opportunity to understand the source of others' unease. This group includes Aspy, along with several others who have requested to remain anonymous.

The following screenshots are timestamped personal notes recorded by one member of the group for their own reference. They represent a shorthand, 'play-by-play' account of the events that occurred and the issues that needed to be addressed during the call.



This screenshot provides a summary of the events related to the unsolicited phone calls. These notes were recorded to determine how best to address and confront the behavior, while also ensuring that Alton was given an opportunity to reflect and improve. It is important to emphasize that the call held on the night of July 12th, 2025 (technically July 13th due to the time being past midnight) was motivated by care and concern. The group who reached out to Alton did so with the intention of supporting his personal growth, helping him understand why his actions were problematic, and encouraging him to consider constructive ways to improve.

This screenshot is also dated July 13, 12:17AM. These are personal notes on what to discuss with Alton so that he could improve from this incident. It encapsulates what the group wished to discuss.


- SHOW DON'T TELL. DON'T IMMEDIATELY CALL PPL AND APOLOGIZE. GIVE PPL SPACE
- discuss boundaries
- make it about group boundaries, not personal rejection, eg. not including him is for the comfort of everyone not just the invitee/event coordinator
- mention it's not okay to self-invite or demand inclusions into events
- remind him that comfort isn't rejection: he seems to interpret discomfort/exclusion as betrayal or dislike
- space \neq hatred. sometimes people need room to process or feel safe

- maybe discuss that confrontation makes people uncomfortable - very pressuring

- bro needs to take time before sending emotional texts or calling people
- being invited into spaces (like the discord server) is about trust and group comfort and not entitlement

The person who made the notes app summary did not take part in the confrontational phone call that happened with Alton, so here is a provided screenshot from one of the people who did have the phone call with him, summarizing what had happened. Please note the 3:06AM timestamp which was the same night of July 13th, 2025.

Additionally, a topic of conversation during this phone call involved the discriminatory friends that Alton affiliates himself with. Details of that matter can be found in the [Persistent Racism](#) tab of this document.




It went really smooth and very understanding, we didn't hit any of the hard points and didn't name drop. The main reason was because he genuinely did all those things out of panic and we mainly just focused on like, don't take it personal, like people are going to have their own friend groups outside of school and club activities and we did touch on the issue of people being uncomfortable with him and it's best to maintain the comfortability of guests during events and stuff instead of trying to bring in people and have a mix of vibes. We told him to just lay low and take it slow and things will eventually dissolve, take time to reflect on actions you've done and don't immediately apologize and just call people asking loaded questions. Saying trust us we still are your friends and just because you don't get invited to stuff doesn't mean it's because we hate you but just slow things down and let us come to you. Also that to go to [redacted] or me if there needs to be another meeting or something

Harassing Spacey

Incident 1: Spacey Call Out/Phone Call Convo

On June 11th, my friend group and I made a Discord server where we would plan hangouts. It was decided that Alton would not yet be invited, as he was on a multi-week-long trip in Europe. Eventually, I got uncomfortable with the idea of him joining the Discord server and decided not to invite him.

In early July, one of our friends held a party that he was not invited to (referenced in the [previous page](#)). He found out about the server and proceeded to message me in what seemed like a condescending way, as the following screenshot shows:

I believe that his entitlement stems from the belief that he can join any small group in the CSUF furry club since he saw it as “his”. He apologized to me (in the screenshot below) after he had been confronted and expressly **told not to solicit me**. I did not respond as I felt he was intent on saving his relationship with me rather than being sincere.

A few months later in September, a friend came to me and told me that Alton was harassing Cinna for information pertaining to if I was badmouthing him or not. According to the screenshots at the very bottom of this tab, Alton believes that I am spreading misinformation about him and badmouthing him when the most I've done is tell people that I am uncomfortable with him. Alton also refers to having proof of his claims, but I am completely clueless as to what it could possibly be. No specific incident was discussed in private with anyone except a few people. I would only express my general discomfort and not wanting to hang out.





On September 9th, I received a random text from Alton asking if I had time to call. I was en route to work so I declined, but I offered to converse over text.



A few hours later after not receiving a text from him, I followed up with another text during my shift in case he wished to discuss any urgent matters. He then asked me if Spacey had said anything about him to me within the past few days. I said no, as at that point I had never heard Spacey explicitly say anything to me regarding Alton or his actions. He proceeded to claim that Spacey had been going to various nondescript people, spreading things and “talking shit” without presenting any concrete proof. I never inquired about this supposed evidence, as I did not desire to escalate the instigation that was already initiated. I then advised him on methods to potentially make amends with Spacey and preserve his reputation (if Alton's claims of slander were true). **Screenshots of this conversation are provided below.**



During this conversation he also brought up a party I was planning for AFC questioning why he was not invited. A day or two prior to this conversation he had requested an invitation to this party. I asked the invitees to seek my approval first, before making the party known to any potential plus-ones, so having him directly solicit me for an invite when he was not invited made me uneasy, and I declined. I thought we had settled the matter back then, so hearing the question be pressed further in the same conversation regarding Spacey made me even more wary.

















It is important to note the date of these conversations, September 9th and 10th, as more misconduct and harassment would happen after Alton promised to do better in these conversations.

Sexual Assault

Sexual Assault

The following tabs are four separate accounts of sexual harassment and assault perpetrated by Alton. Reader discretion is advised.

SA Incident #1

Context

This is my history with Alton. We first met at the pizza place in Brea Mall, along with a few furies we had met around the same time. Everything seemed fine at the time, and we had a good time together. Around then, however, I was struggling—I was already preparing to go to rehab because my cocaine addiction had gotten very bad. I didn't have any self-respect and thought very poorly of myself.

Initial Event

On the day we went to create the club, Alton and I were talking and ended up having sex. At the time, I didn't think much of it—it just happened. Afterward, though, Alton would often message me and put himself in my space at events and other social gatherings. I asked him to stop. He somewhat did, but not fully.

Incident at FC 2025

At Further Confusion 2025, I was already under a lot of stress, and this led to my relapse into cocaine use. That night, I did express that I was under the influence of cocaine shortly before Alton tried to kiss me at a room party. I expressed disinterest; however, it did feel forced. We did end up going back to his room and engaging in oral and anal sex in his room (which he was sharing with Anonymous-C), but I wasn't truly comfortable with it, and I felt pressured into it.

Other General Misconduct

When the school year started, Alton would poke at me, hover around me, and constantly try to get my attention. Both Anonymous-C and I noticed this, which made me feel extremely uncomfortable. At one party, while I was cuddling with a friend, Alton came over and physically put himself between us without asking us beforehand. He tried to get my attention by taking off my socks and generally being a nuisance while drunk. Anonymous-C had to tell him off and made him get water. Later that same night, while I was talking to Anonymous-D, Alton again tried to sit next to me. Anonymous-D immediately noticed and told him that I was clearly not interested and did not want him around, which made him leave me alone.

Overall, this has been my experience with Alton. It has left me feeling a lot of shame and frustration, especially because he does not respect my space or take hints when I've made my boundaries clear.




SA Incident #2

Context

In March, Mia, I, and some other online friends whom I had never before met, including Alton, planned a meet-up trip, and at the time, Alton and I had become rather close online friends through coordinating this trip. Shortly before the trip, we had discussed the possibility of us having sex. We set up some ground rules and agreed that, if we were feeling it, we would try having sex.

Something additional that I would like to note is that, due to prior negative sexual experiences, I struggled to maintain a healthy or typical sex life and experienced long-term feelings of deprivation. As a result, during this stage of my life, I actively sought sexual attention, which influenced the nature of my relationship with Alton.

The Lead Up

From the first night of the trip, Alton remained very close to me. While he didn't make a lot of advances at first, he often poked my stomach and felt my butt and thighs. At the time, I was tolerant of his actions and framed it as letting him have his fun. Later in the night, the lot of us drank and became very inebriated. As the night was winding down, Alton and I decided to settle in his room to potentially pursue intercourse (if the feeling was right). We both began to undress into our shirts and undergarments. I started to feel very uncomfortable as we laid and chatted in bed for a bit. After slowly inching toward me in bed, Alton finally asked if we could have intercourse. I told him I wasn't ready, which led him to stop making sexual advances temporarily, and we resumed chatting. It continued like this over the course of an hour or two, in which he progressively got closer to me. First, we were lying next to each other, then we were pushed up side by side, then he was over top of me, and then he began to do things like rub my belly, and lick it. Notably, he continued to insist that we just go for it, which I had to keep declining.

Biting / Crossing boundaries

Eventually, I said, "I don't think I can do this," which made him pause. At that moment, I felt bad. I can't quite remember who said it, but one of us suggested foreplay, which we decided to try. He asked what he could do, to which I said, "I don't know." After that, he immediately went for my arm and began to bite vigorously. I was shocked and unable to say or do anything except ask, "Are you biting me?" I don't remember the response he gave, but he then moved to kiss me, and I turned my head away. He then forced his body upon mine and began biting again. The shock then began to give way to pure terror and I started to burst into tears, my past trauma

resurfacing in that moment as he bit me and pressed his body against mine. I vaguely remember saying "I'm worthless" in my hysteria, before he finally stopped entirely.

We then sat in bed for a little bit as I recovered. At the time, I couldn't understand what I was feeling. Alton attempted to comfort me, I told him I was sorry, we exchanged some words, and I got up and went downstairs to my bedroom. For the rest of the trip, he seemed to get closer, hanging off me and staying by my side probably 80% of the time. During that time, he kept groping my butt and poking my stomach. On one of the days, he cupped my breast, completely unprompted, which I immediately smacked his hand away and told him not to do.

On the last night of the trip, we once again tried to have sex; however, I was still recovering from the first night regarding the prior sexual encounter. We sat in bed, drunk once again. Like before, we just chatted. He laid beside me and proceeded to take off his pants. I then just stared as he bared himself to me, and he told me I could feel if I wanted (referring to his penis). Once again, he insisted that we should just go for it, but he didn't make any advances like last time. We eventually just laid there, browsing Twitter and looking at NSFW art, before I finally decided to give up. I went downstairs, and as I began to pack my things, he entered the room behind me. He sat at the edge of the bed for a minute before laying down next to Mia, and then asked if he could sleep with us that night. We both expressed discomfort and told him that we didn't think it was a good idea. He accepted our refusal and went back to his bedroom.

SA Incident #3

Context

Back in March, Destiny, Alton, a couple of other friends and I had planned a meet-up trip. This is the same trip from Destiny's statement. From day one, Alton did not seem to be subtle about his sexual desires and, for the most part, his comments and actions would always make me uncomfortable, so I tried my best to keep my distance from him. After this, the rest of the trip until the last day was fine, but I do remember having to tell him that subtlety wasn't his strong suit at all, and he should at the very least try to be more tame about it.

Groping Me in the Car

Most of the last day of the trip went without too much issue. However, his disturbing behavior took a severe turn after we parted ways with one of our friends who was leaving early. We drove back from the airport in a very cramped car, and, due to space issues, we decided to have me sit on Alton's lap. He began to tickle me, and then he started to grope and poke my breasts out of nowhere. I had made him aware, both before and during the trip, that I was in a relationship at the time, but he persisted in groping my breasts and dismissed the act as merely tickling me for fun. I was just sitting awkwardly telling to stop because I didn't find it funny. At that moment, I didn't realize the gravity of his actions while I was helpless.

Further Sexual Misconduct

On the last night of the trip, we got really intoxicated while watching a movie. The three of us were cuddling on the sofa, when Alton slowly reached for my breasts and started to grab them. I just laid there, awkwardly looking at him. According to him, I told him in Spanish that I was okay with it. . This was not the case as I told him he could feel my torso, just this once. Right after, he began to move his hand down my body, and towards my groin. I noticed and I told him that I wasn't ok with that. He then stopped. . However, following that, he tried to kiss me. He went for my mouth, but I refused and had to stop him again. I told him that he is not allowed to do that to me, and he relented.



Once the movie was over, everyone finally went to bed, except for Destiny and Alton. I started to fall asleep, and after some time, Destiny entered the room and I noticed that she was a bit shaken up by something. I did know he and Destiny had been trying to have sex. Therefore, I didn't ask, as I feel it didn't involve me. Once Destiny started to pack her stuff, Alton came into our room, trying to start a conversation. He then started to tuck himself into our bed. He continued the conversation as he did so, before suddenly asking if it was ok to sleep in the same bed for that night. We both expressed our discomfort with the idea, and we refused.



Instigation and Further Harassment


Once the trip had ended, there was a night where we were just hanging out and talking in a voice call via Discord with an ex partner of mine, when Alton suddenly joined. We were talking about the trip, and after a few sentences Alton messaged my ex and told them that "your girlfriend has very soft breasts." This got a severe reaction and caused her to become furious with Alton. They then told me that I should've been more careful since I didn't realize how bad the whole situation really was. Later he attempted to apologize and, although I said I forgave

him, I mostly wanted to stop talking about what happened. Regardless, the feelings I had about what he did to me never went away.



SA Incident #4

Context (First Incident Chronologically)

During GSFC 2025, Alton and I were engaging in flirty, touchy behavior that I was uncomfortable with. I did not communicate this as I felt afraid to say no. At the time, I identified as a lesbian as I felt this way. He did not really care about the title, as he would still try to engage in this type of behavior.

It should be noted that before GSFC, I had no intention of engaging in any form of sexual activity during the convention.

Sexual Coercion

On Friday night, he invited me to his room and got close to cuddle me. There were a few others in the room that he was trying to remove from the room. I was visibly uncomfortable and told Alton that the others in the room could stay. He was drinking to the point where I could smell the beer on him and his breath. He started making physical moves on me, which eventually resulted in intercourse, with which I was consenting at first. When he entered me, I wanted it to stop immediately. I should have said no and to stop, but I was terrified of what he could do, especially while intoxicated, as a result of other past traumatic experiences I have had. After it was done, I had to leave since my ride was leaving for the night.

Follow-up

A few months later, in a call with Alton, I brought up how what he did made me feel uncomfortable. He responded by saying something similar if not word for word to "I'm sorry you felt that way." I felt that he dismissed the gravity of the situation and provided, in my opinion, an inadequate apology. Upon saying bye, he chirped my name in a high-pitched, seemingly mocking tone. I was astonished and didn't respond, and he then hung up on me.

Context (Second Incident)

On June 9th, I went to a pool party with Alton and a big group of friends. I decided to drink for the first time and I got buzzed. Alton was also drinking at this time.

Unconcentual Groping and Kiss

I was hanging out by the corner of the pool by myself. Alton approached me and we talked for a bit, but he suddenly began groping my stomach under the water. Nobody could see what he was doing to me, as everyone was far from the corner we were at. I gave him a weird look and nudged him away. He proceeded to back hug in the water and quickly tried to kiss me on the lips, but landed on my cheek because I moved away. I was extremely uncomfortable and I pushed him away and told him to stop. It made me feel sick for the rest of the night and I tried avoiding him as much as I could. At no point during our interaction did I consent in any way to his groping or kissing.

Follow-up

We spoke a few weeks later in a call. I brought up what he did to me, and he responded with a promise that he would never do something like it again and asked me if we could be friends again.

Ending Notes

Alton's behavior toward me has caused me immeasurable shock and distress, and these two separate incidents have, in my opinion, clearly illustrated that he lacks awareness for peoples' boundaries, is unapologetic when confronted with his actions, and is subject to reoffense.

I have been extremely nervous to come out about this in any capacity and I am remaining anonymous for my own safety. I felt disgusted with myself after what Alton did to me and it's traumatic for me to think about and be near him. My disturbing ordeal with him has led me to keep him at an arm's distance away. I forced myself to keep up courtesies with him under fear of him spreading these situations around.

Closing Statements

Closing Statements

This document was written by a multitude of individuals whom Alton negatively impacted. We collectively decided to write this report in an effort to protect our community, to support those whom Alton has victimized, and to ensure that he takes accountability for his actions.

The numerous incidents enumerated throughout this document are not isolated. Alton's actions are part of an ongoing pattern of abuse and deceit, not a one-time mistake. Rather than marking a turning point, each apology has been followed by further misconduct. His cycle of apology and reoffense shows a fundamental disregard for genuine accountability, and this is the primary basis for why this document was written.

This kind of behavior cannot be tolerated or normalized, and awareness must be raised in order to keep our space safe and to prevent further victimization. Alton weaponized his position as the president of Cal State Furryton to harass and abuse those he should have been protecting. This underscores how essential accountability is, especially to the furry space which is built on trust, respect, and inclusivity.

We stand with both the individuals who came forward with their experiences and those who were unable to; their testimonies are deserving of recognition and respect. This document was not written lightly. It is a collection of harrowing testimonies from many individuals. Our goal is not defamation. It is a call for accountability—not just from Alton, but from all of us—to ensure that our community remains a safe and respectful space for everyone.
