## **TCGL** End of Season Meeting Tuesday, March 23, 2021 At Del Webb

- **1. Call to Order** by Chairperson Marcia Sidwell.
- **2. Roll Call of Officers** Chairperson, Marcia Sidwell from Del Webb; Vice-Chairperson, Elaine Butler, from Plantation; Secretary/Treasurer, Karen Decker from SummerGlen, All present.
- **3. Roll Call of Team Managers/Reps** by the secretary.
