Meeting Purpose: Open discussion on providing access to digital archives and reading rooms.

Key Takeaways

 Most institutions are still using interim solutions like Google Drive and Box to provide access, not full digital asset management systems.

- There is interest in solutions that provide folder-level access and browsing for researchers, rather than item-level records.
- Privacy and restricted access are major concerns when providing access to digital archives.
- Al offers potential to improve access and analysis, but human intervention is still needed.

Topics:

Current Practices

- Many institutions still rely on traditional reading room practices researchers request items, archivists prepare and provide access on a laptop.
- Google Drive, Box and Dropbox are common interim solutions to provide access remotely.
- Some systems like Leapnova allow configuring robust permissions for different types of users and access levels.

Desired Capabilities

- Folder-level access and browsing is desirable rather than access via item-level records in DAMS.
- Access controls are needed for restricted or sensitive content.
- Less mediation from archivists for each request is needed to scale access.
- Registration system could provide access based on user credentials and restrictions.

Privacy and Restricted Access

- Restricted, sensitive or private content is a major concern. Access needs to be controlled.
- Some systems allow configuring embargoes and access restrictions at the item level.
- Communication between archivists and developers is important to implement appropriate restrictions.

Potential of Al

- Al could help with processing tasks like appraisal and metadata generation.
- It may change discovery and analysis, allowing new insights into collections.
- But human intervention is still needed for oversight.

Next Steps:

- Consider a future discussion focused on privacy concerns and access restrictions.
- Continue sharing experiences with providing access to digital archives.
