

### **Details of template for full paper submission for proceedings**

**Page Layout:** A4, portrait, 1" margins

**Font:** Times New Roman 12 pt, for Symbols use menu Insert>Symbol (Font: Symbol 12 pt). Justified alignment with the headings in Bold and subheadings in italics.

**Paragraph Style:** Single line spacing and fully justified, except for the title, authors, and affiliations, which should be left-justified. Spacing before and after paragraphs should be set to 0 pt (i.e. no spacing between paragraphs). Do not use blank lines to separate paragraphs. Indentation should be made manually by using Tab. Autoindent and autonumbering features in Word should be disabled.

**Other:** The length of a full paper should be between 8-10 pages. Delete all the “red” text before saving. Save the file in Word doc (.doc) format with no more than 5,000 words, excluding abstract, references, tables, and figures.

(Times New Roman 12 pt, include country name, without full stop)

<sup>2</sup>Affiliation of 2<sup>nd</sup> author

(No spacing before and after paragraph)

<sup>3</sup>Affiliation of 3<sup>rd</sup> author

(Combine the affiliations that are shared by more than one author, Do not use numbers if all authors share the same affiliation.)

### **Abstract**

This format is used for the preparation of your abstract. Please follow this guideline strictly. The abstract must be prepared by using the Times New Roman font with 12-point. Please check your abstract carefully before submission and be sure that there are no typo-errors and grammatical errors in the abstract. The abstract must be written in English for one paragraph that contains brief background of the topic and significance of the study; the major aim of the study; brief summary of study setting and number of participants; the study design; major methods used to collect and analyse data, including the proper name of instruments used; the major findings; and conclusions and implications for nursing practice (do not show the section titles) and must not exceed 250 words. **Abbreviations, references, statistical information and sub-headings are not to be included.** The authors have to provide 3-5 keywords.

**Keywords** (3-5 keywords): aaaaa; bbbbb; xxxxx; yyyy; zzzzz

- **Full paper:** the following sections are to be included:
  - **Introduction**
  - **Review of Literature**
  - **Study Aim; Methods (including sub-sections of Design, Sample and Setting, Ethical Considerations; Data Collection; and Data Analysis)**
  - **Results**
  - **Discussion**
  - **Limitations**
  - **Conclusions and Implications for Nursing Practice** (Practice can include settings where nurses work, future research studies, education, management or nursing policy. Ensure there is no duplication of content in various sections. Include the name of the primary ethics committee giving approval for the study and the approval number.
- **The first time an abbreviation is used**, please state the words in full followed by the abbreviation in parentheses, for example: “The World Health Organization (WHO) definition of...”. Thereafter, the abbreviation, without parentheses, may be used.
- **Avoidance of labeling of people:** Be very sensitive to this in your writing. For example, do not use “diabetic mothers” (use “mothers with diabetes”) or “schizophrenic patients” (use “patients with schizophrenia”).
- **Acknowledgments:** Briefly acknowledge research funders, and any research participants.
- **References**

The **Vancouver System for references and citations** is to be used as described at <http://www.nlm.nih.gov/citingmedicine>. Citations in the text are to be made using superscript Arabic numerals in the order in which the citations appear, and after punctuation where possible. All references are to be listed as citations in the text, and all citations are to correspond with the appropriate reference. References are to be listed in order of appearance in the text. **Citations in the text are to match the reference list.** Include DOI numbers for publications where these are available.

Names of all authors are to be cited when there are six or less. When there are seven or more authors the first six authors are to be listed followed by et.al.

Reference to unpublished data and personal communications should appear only in the text.
