

Terms & Conditions of Vehicle Use

ElectRaeid ("we, us, our") is a political organization that highly values the safety and security of all volunteers. These terms & conditions govern the use of personal motor vehicles while volunteers are engaged in any campaign activity.

- 1. Driving for ElectRaeid is a privilege, which may be suspended at any time for any reason. A charge of a major moving violation is automatic grounds for suspension.
- 2. Any volunteer under the age of 18 and who is not emancipated must have permission from their parent or guardian to operate a vehicle while engaged in any ElectRaeid activity.
- 3. Volunteers will be automatically disqualified from operating a vehicle if they have ever been convicted of a major moving violation, including, but not limited to: driving under the influence, reckless driving, vehicular manslaughter, or street racing.
- 4. All volunteers attest that the vehicle they operate for ElectRaeid is properly registered, insured, and inspected in accordance with the laws of Virginia.
- 5. Any vehicle not registered in the name of the volunteer must produce a signed, written statement from the individual to which it is registered acknowledging these terms.
- 6. All volunteers attest that they have a valid, unexpired driver's license in Virginia. Learner's permits are not accepted.
- 7. Volunteers must follow all traffic laws and regulations, and must refrain from speeding or driving in an unsafe manner. The violation of traffic laws is grounds for suspension of driving privileges.
- 8. Volunteers will operate their vehicle in a safe, respectable, and predictable manner while engaged in an ElectRaeid activity. This includes, but is not limited to: refraining from using the horn unless necessary, using turn signals when turning or changing lanes, and refraining from engaging in risky driving behavior (including tailgating, speeding, quick acceleration and braking, etc). Violations are grounds for suspension of privileges.
- 9. **Operating a vehicle incurs inherent risk**. ElectRaeid takes no responsibility for any damages, injuries, or loss of life incurred while operating a motor vehicle, either while engaged in an activity with ElectRaeid or while driving to and from home. All volunteers accept and incur this risk voluntarily.
- 10. ElectRaeid does not assume any responsibility for the costs of operating a motor vehicle, including, but not limited to, costs of gasoline, electricity, repairs, or inspections.
