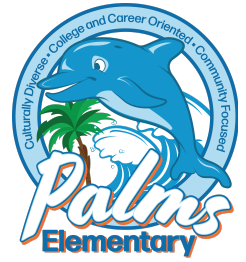

I.	<p>Welcome/Call to Order</p> <ul style="list-style-type: none"> The hybrid meeting was called to order at 2:45PM by Sophia Webster-Quiroz, TSP/CPA.
II.	<p>Flag Salute</p> <ul style="list-style-type: none"> The committee declined to conduct the flag salute..
III.	<p>Public Comment</p> <ul style="list-style-type: none"> A moment was presented for public comment. No non-committee members were present, and no comments were made.
IV.	<p>Roll Call (Action)</p> <ul style="list-style-type: none"> Roll call was conducted by Sophia Webster-Quiroz, TSP/CPA. 9 out of 10 members were present. Quorum was established. Sign in and Zoom usage report are attached.
V.	<p>Approval of December Minutes (Action)</p> <ul style="list-style-type: none"> Committee members were given a chance to read the minutes from the December meeting. Afterward, there was a time for corrections. No corrections were suggested. Michelle Peters made a motion to approve the minutes. The motion was seconded by Donald Kelly. 9 were in favor, 0 opposed, none abstained. The motion passed and the minutes were approved.
VI.	<p>Review Title I and TSP Plan and Budget Allocations (Presentation)</p> <ul style="list-style-type: none"> Sophia Webster-Quiroz, TSP/CPA, gave an update on the outcome of 2026-2027 budget development in the Title I and TSP budgets. She shared that the budgets had been approved as agreed upon in the December meeting. Some adjustments were required due to the need to pay classified staff members' benefits, and these were made in accordance with the agreed upon contingency plan. Sophia Webster-Quiroz also shared information about approved expenditures in the TSP plan, including a CSR teacher, five 3 hour/5 day supervision aides, money for the Toshiba contract, and the TSP Advisor. A time was provided for members to ask questions and provide feedback. No comments or feedback were given.

The topic will be reviewing MOY iReady data and other Title I updates. Parent members were reminded to submit their School Experience Survey completion verification page to their children's teachers.
