Hi Max,

NZ has about 30 major adult gangs with approximately 4000 patchmembers and prospects.

Adult gangs comprise of outlaw motorcycle gangs (such as the Hells Angels and Head Hunters) and gangs such as the Black Power, Mongrel Mob and Nomads.

The Mongrel Mob is our largest gang with about 1500 members followed by the Black Power with about 1200 members.

The Mongrel Mob has the largest presence in our prisons and makes up about 10% of the prison population.

There is no easy way of dealing with the gang problem as gangs are entrenched in many parts of NZ and gang membership often involves strong family ties including several generations of the same family.

A comprehensive gang plan involves a number of components including community involvement, prevention, intervention and suppression.

Key parts involve preventing people from joining gangs, assisting gang members who want to leave gangs and suppression (policing gangs- supported by legislation and adequate resources).

The NZ Govt created a whole of government action plan to reduce the harms caused by adult gangs. As part of this a multi-agency Gang Intelligence Centre was created and this brings together information held by Social Development, Customs, Corrections, Internal Affairs, Immigration and Police.

Hi Max,

Gang members are already banned from wearing gang patches in Government Premises (due to the provisions of the Prohibition of Gang Insignia in Government Premises Act 2013). While I think that this is a good idea, I'm not in favour of a law totally banning gang patches. Gang members don't need gang clothing to intimidate. Patches add to the intimidation level but take them away and you've still got a gang member. Gang members do not wear patches in prison, but they still control the place. The behaviour of gang members is the issue, not the clothes they wear. If their behaviour is unacceptable it should be dealt with promptly by the police.

Gang clothing lets the public identify gang members. A family who sees a group of gang members may decide that they don't want to go anywhere near them. People seeing rival gangs near each other may choose to remove themselves from a potentially dangerous situation.

Gang clothing lets the police identify gang members and provides valuable intelligence. Gang members may be wearing crash helmets or balaclavas when they commit violence or other crimes but they can still be identified by their clothing. New Zealand Police have identified gang members for serious crimes purely by their gang clothing.

When there's an incident of serious violence, the sooner the police can identify that gangs are involved, the sooner they can identify potential suspects and take steps to catch them. Take the example of a gang fight where the offenders have taken off, leaving one person seriously injured. If none of the gang members are wearing gang clothing it will take much longer to find out who is involved. If the cops knew straight away that the Black Power and the Mongrel Mob had clashed they could immediately take steps to locate the offenders by checking gang addresses and looking for known vehicles. Time is often critical during the early stages of an investigation because offenders will destroy evidence (weapons and bloodstained clothing etc), arrange alibis or find somewhere to hide.

The problem with anti-gang laws that make gang members leave is that the only ones who generally leave are those more moderate members (including uncommitted members, those near retirement or with a weak heart) which means that the remaining members become more hardcore and no longer have the influence of the more moderate members to help keep them in line.

I think it is a good idea to have gang education in schools because it is much easier to keep

people away from gangs to get them out of the gang scene once they become involved.

Other initiatives such as free removal of gang tattoos are also a good thing as this helps former members move away from gang life.

There are many more police working in the gang/organised crime field than there were when I was in the cops but those that I know say that they are still very busy and feel that more police would result in more gang members being prosecuted.

Hi Max,

Sorry about another slow reply.

Police numbers have remained at about 8800 since 2008. (Interesting when you compare this with around 4000 gang members and prospects in NZ). Population growth over this time has seen the ratio of police to population shrink from 1 in 500 to 1 in 530, although both National and Labour are promising more police in the build up to the general election.

The main group of police who works on organized crime (including gangs) is now known as the National Organised Crime Group. (This was formerly known as OFCANZ)

Anti-social gang behavior (street disorder etc) isn't a big issue and regular frontline staff are usually well equipped to deal with it. Serious crime (including violence and major drug offending including manufacturing and selling methamphetamine) is much more difficult to police and requires considerably more time and resources. If you were wanting to reduce gang offending by adding more police, then the National Organised Crime Group would be probably the best place to send them.

There's no single "silver bullet" to fix our gang problem and any comprehensive gang plan involves a number of components, such as things that you've already mentioned like anti gang

	programs in schools and programs designed to help gang members who are wanting to leave the gang environment, as well as policing gangs (which is generally known as suppression).
	The book "Patched" by Jarrod Gilbert about the history of gangs in NZ is a very good reference point and is worth reading.
