- **I. Welcome and Pledge of Allegiance** Meeting called to order at 7:00 pm.
- II. 2025 Band Trip to Disney Mr. Mirabella
  - a. Approved for December 16, 2025-December 22, 2025
  - b. Mr. Mirabella and Mrs. Lucci wanted to do something different and do the parade at Christmas.
  - c. Choir candlelight performance
  - d. Hope to be accepted to march in Magic Kingdom in afternoon or evening to march in parade.
    - i. This is something new for the school.
  - e. Orchestra will be doing something completely different no performance at Universal; performance will be at a Disney property.
  - f. There will be plenty of time to raise funds for the trip.
  - g. Pricing is relatively the same at this time of year compared to last trip.
  - h. Hotel prices were higher during spring break season when compared to "out of season"
    - i. Looking to stay at the same hotel as last year.
  - i. Chartering a flight we are at the middle-sized charter right now. If we get more kids, we can get a larger charter; if we have fewer kids, then we can get a smaller charter.
    - i. We pay for all the seats on the charter flight regardless of the # of kids flying.
  - j. Pricing right now = approximately \$2300 per child
  - k. Fuel surcharge pricing fluctuates.
    - i. Per Mr. Mirabella, we have not received any fuel surcharge.
  - I. We are looking at only going to Disney Properties on this trip.
  - m. Mr. Mirabella needs to send in a video of the band performing.
    - i. He sent in a video of a festival performance and the veterans day parade performance
    - ii. He also sent in a full picture of the entire band.
    - iii. Then, Disney will tell Mr. Mirabella if we are accepted to parade at Magic Kingdom.
    - iv. Mrs. Lucci has to do the same thing with Chorus.
    - v. Orchestra and Band will be doing another event, too, on a different day at one of the Disney Properties it's a very nice activity with Disney folks.
  - n. Cut Time is a new program for communication and other information that Mr. Mirabella plans to use moving forward. So far, each student in Band, Chorus, and Orchestra has signed up for the program. If you haven't already, you will be getting an email saying hello from the program Cut Time. We are transitioning to this program in lieu of One Call.
    - i. Please note: Cut Time has not officially "gone live".
    - ii. The Band Patrons Board needs to familiarize themselves with the program to maximize its capabilities.
    - iii. Cut Time has the ability for parents to track their child's GSA balance.
    - iv. More information will be forthcoming.
    - v. One Call will continue to be used for the 2024-25 school year.
  - o. Lucci and Mirabella will be meeting with 8<sup>th</sup> graders who will be joining band, auditioning for Auxiliary.
    - i. 8<sup>th</sup> graders will start fundraising in January 2025.
    - ii. Normal year if we would have the trip in the spring, no fundraising would happen until band camp in August and basically would have ability to raise funds until February.
      - 1. So, 8<sup>th</sup> graders and new members will have 11 months to raise funds.
  - p. Mr. Mirabella cannot say that after Spring in 2026 that prices will be the same. Disney changes prices all the time, sometimes as much as 25% increase from one year to the next.
  - q. Kids will get a 4 day park hopper pass for the Disney parks. As of right now, Universal Studios is not included in the trip.

- i. This is subject to change.
- ii. There are rules around getting tickets to the New Mario Land at Universal.
- r. The trip will not always occur in December moving forward.
  - i. When planning the trips, they:
    - 1. Try to avoid the AP Exams and the PSSA tests.
    - 2. Depends on when Easter falls within the year.
    - 3. We have gone after the musical at the end of March one year.
- s. We always offer travel insurance, but we will encourage getting the travel insurance for this trip.
- t. Keep in mind: The band patron officers and fundraising committee have been remarkable in offering what you need for fundraising and working hard to keeping everything on track with the trip.
  - i. One place we can't do is the Hoop De Doo Review due to cost.
  - ii. If things can be tweaked for the same price, things may change slightly. If the price goes up, it won't be on our side of it.
- u. We are in the process of scheduling the Disney trip meeting for January 2025.
  - i. Mr. Mirabella and Mrs. Lucci were hoping to schedule this meeting for 1/7/25.
  - ii. Suzi informed the group that this is Orthodox Christmas.
  - iii. Sarah emailed Mr. Mirabella and Mrs. Lucci informing them of this and asking for an alternate date for the Disney Trip Meeting.

## v. QUESTIONS

- i. Laura: If you have a child in majorettes and chorus, will they attend all the performances unless there's a conflict?
  - 1. There is no conflict. We do schedule the different events on different days so that everyone can participate. There is no need to pick one activity over another.
- ii. Beth: the 16<sup>th</sup>-22<sup>nd</sup> of December 2025 is Tuesday through Monday
  - 1. Yes, we will leave Tuesday after school and come home Monday.
- iii. Meredith: When would be a timeline of when they will be accepted to perform?
  - 1. We'll get that mid-September or so, hopefully. Disney will let us know in time.
- iv. Christin: If they don't accept you for the parade, will you still go in December?
  - 1. Yes, there are other things that we can do.
- v. Mariann: When is the payment going to be due?
  - 1. We need to talk about that and figure out the flow.
  - 2. By February we need to know who is going on the trip.
  - 3. We meet with the middle school in January.
