## About this Privacy Policy

Aleksandr Fedorov built the game (the "App") as a Commercial app. This App is provided by Alex Fedorov and is intended for use as is.

### **This Privacy Policy explains:**

- What information I collect and why I collect it.
- How I use that information.

If you choose to use my App, then you agree to the collection and use of information in relation to this policy. I will not use or share your information with anyone except as described in this Privacy Policy.

## Definitions

- 'NON-PERSONAL DATA' is information that is in no way personally identifiable.
- 'PERSONAL DATA' means any information relating to an identified or identifiable natural person ('data subject'); an identifiable natural person is one who can be identified directly or indirectly by reference to an identifier such as a name, an identification number, location data, an online identifier, or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person. PD is in many ways the same as Personally Identifiable Information (PII). However, PD is broader in scope and covers more data.
- 'GDPR' means the EU General Data Protection Regulation (2016/679).
- 'COPPA' means the US Children's Online Privacy Protection Rule.
- 'CCPA' means the California Consumer Privacy Act of 2018.

## Information I collect and how I collect it

I don't collect and use PERSONAL DATA

### Analytics data

I use our third-party analytics service providers:

- Firebase (<https://firebase.google.com>) offered by Google LLC
- Appsflyer (<https://www.appsflyer.com/>)

which automatically collects the following technical personal and NON-PERSONAL DATA from you:

- Session duration
- Operating systems

- Device models
- Geography
- First launches
- App opens
- App updates
- In-app purchases
- In-app events

I use such data to:

- Analyse the technical aspects of your use of Apps;
- Optimise Apps for your needs;
- Prevent fraud and abuse of Apps; and
- Ensure the security of Apps;

I want to inform you that whenever you use my App, in a case of an error in the app I collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing my App, the time and date of your use of the App, and other statistics.
