Terms and Conditions for For the Kingdom 2026

Last Updated: October 10, 2025

By purchasing a ticket for For the Kingdom 2026 (the "Event"), a confessional Presbyterian religious conference organized by Presbyterians for the Kingdom Inc. (the "Organizer") and held at Providence Presbyterian Church, Hilton Head Island, South Carolina, on March 2-3, 2026, you (the "Participant") agree to be bound by the following Terms and Conditions (the "Terms"). Purchasing a ticket constitutes your full acceptance of these Terms. Please read these Terms carefully before purchasing a ticket or attending the Event. If you do not agree to these Terms, you may not purchase a ticket or participate in the Event.

1. **Event Registration and Participation**
 - 1.1. **Registration and Ticketing:** Purchase of a ticket is subject to availability and approval by the Organizer. The Organizer reserves the right to refuse ticket sales or entry to any individual at its sole discretion, without explanation, particularly if participation conflicts with the confessional Presbyterian values of the Event.
 - 1.2. **Eligibility:** Participants must be at least 18 years of age or accompanied by a legal guardian. By purchasing a ticket, you confirm that all information provided during registration is accurate and complete.
 - 1.3. **Code of Conduct:** Participants are expected to behave respectfully and in accordance with confessional Presbyterian values and Christian principles, as informed by the Westminster Standards, toward all attendees, staff, volunteers, vendors, and venue personnel at Providence Presbyterian Church. Prohibited behaviors include, but are not limited to, harassment, discrimination, disruptive conduct, or actions that violate the doctrinal or ethical standards of the Event. The Organizer reserves the right to remove any Participant from the Event for violations of the Code of Conduct, without refund.
 - 1.4. **Event Changes:** The Organizer reserves the right to modify, postpone, or cancel the Event, including changes to the schedule, speakers, venue, or format (e.g., in-person to virtual), due to unforeseen circumstances, including but not limited to acts of God, natural disasters, government restrictions, or insufficient registration. No refunds will be issued for such changes unless explicitly stated by the Organizer.
 - 1.5. **Religious Nature:** The Event is a confessional Presbyterian religious conference intended to promote worship, fellowship, and teaching in accordance with the Westminster Standards and Presbyterian doctrine. By purchasing a ticket, Participants agree to respect the religious purpose and content of the Event.
2. **Hotel Room Assignments**
 - 2.1. **Participant-Managed Room Assignments:** The Organizer does not arrange, assign, or facilitate hotel room accommodations for Participants. Participants are solely responsible for securing their own

accommodations in or around Hilton Head Island, South Carolina, for the Event on March 2-3, 2026, including finding and coordinating with roommates if they choose to share a room. 2.2. Discord Chat Platform: The Organizer may provide a Discord server to allow Participants to voluntarily coordinate roommate arrangements. Use of the Discord server is at the Participant's sole discretion and risk. The Organizer does not endorse, verify, or guarantee the suitability, safety, identity, or conduct of any individuals met through the Discord server. By purchasing a ticket, Participants agree to adhere to Discord's terms of service and the Event's Code of Conduct while using the platform. 2.3. Participant Responsibility: Participants are fully responsible for all aspects of their accommodation arrangements, including but not limited to booking rooms, splitting costs, verifying roommate identities, complying with hotel policies, and resolving any disputes. The Organizer is not a party to any agreements between Participants and hotels or other Participants. 2.4. Indemnification for Room Assignments: By purchasing a ticket and using the Discord server (if applicable), Participants agree to indemnify, defend, and hold harmless Presbyterians for the Kingdom Inc., its Board of Trustees, Providence Presbyterian Church, its Board of Trustees, their affiliates, officers, directors, employees, agents, volunteers, and contractors from and against any and all claims, liabilities, damages, losses, costs, or expenses (including reasonable legal fees) arising out of or related to hotel room arrangements, including but not limited to disputes between roommates, theft, property damage, personal injury, harassment, assault, or any other incidents occurring in shared accommodations, whether caused by negligence or otherwise. 2.5. No Liability for Roommate Issues: The Organizer and Providence Presbyterian Church assume no responsibility or liability for any issues, disputes, or incidents arising from Participant-managed room assignments, including but not limited to financial disagreements, safety concerns, compatibility issues, or failure to secure accommodations.

3. Complementary Transportation 3.1. Nature of Transportation: The Organizer may provide complementary shuttle or transportation services to and from designated Event locations, such as Providence Presbyterian Church or nearby hotels, as a courtesy during the Event on March 2-3, 2026. These services are not a guaranteed right of participation and are subject to availability. 3.2. No Guarantee of Service: The Organizer reserves the right to modify, suspend, or cancel transportation services at any time without notice, including due to weather, mechanical issues, scheduling conflicts, or other unforeseen circumstances. 3.3. Participant Responsibility: Participants use complementary transportation services at their own risk. The Organizer and Providence Presbyterian Church are not responsible for delays, missed connections, accidents, injuries, property damage, or loss occurring during transportation. 3.4. Indemnification for Transportation: By purchasing a ticket, Participants agree to indemnify, defend, and hold harmless Presbyterians for the Kingdom Inc., its Board of Trustees, Providence Presbyterian Church, its Board of Trustees, their affiliates, officers, directors, employees, agents, volunteers, and contractors from and against any and all claims, liabilities, damages, losses, costs, or expenses (including reasonable legal fees) arising out of or related to the use of complementary transportation services, including but not limited to accidents, injuries, property damage, or delays, whether caused by negligence or otherwise.

- 4. General Liability and Indemnification**

4.1. Assumption of Risk: Participation in the Event is voluntary and at the Participant's own risk. By purchasing a ticket, Participants acknowledge that attending the Event at Providence Presbyterian Church may involve inherent risks, including but not limited to personal injury, property damage, or theft.

4.2. Release of Liability: To the fullest extent permitted by law, Participants release and forever discharge Presbyterians for the Kingdom Inc., its Board of Trustees, Providence Presbyterian Church, its Board of Trustees, their affiliates, officers, directors, employees, agents, volunteers, and contractors from any and all liability for claims, damages, losses, or injuries arising out of or related to participation in the Event, including those caused by negligence, acts of other Participants, or unforeseen circumstances.

4.3. Indemnification: By purchasing a ticket, Participants agree to indemnify, defend, and hold harmless Presbyterians for the Kingdom Inc., its Board of Trustees, Providence Presbyterian Church, its Board of Trustees, their affiliates, officers, directors, employees, agents, volunteers, and contractors from and against any and all claims, liabilities, damages, losses, costs, or expenses (including reasonable legal fees) arising out of or related to their participation in the Event, including but not limited to personal injury, property damage, financial disputes, or violations of these Terms, whether caused by negligence or otherwise.

4.4. Third-Party Services: The Event may involve third-party vendors, such as hotels, caterers, or transportation providers in the Hilton Head Island area. The Organizer is not responsible for the actions, omissions, or services of these third parties, and Participants engage with such services at their own risk.
- 5. Payment and Refunds**

5.1. Ticket Purchase: All ticket purchases for the Event are non-refundable unless otherwise explicitly stated by the Organizer. Payment must be made in full at the time of purchase via Donorbox.

5.2. No Refunds for Non-Attendance: No refunds will be issued for Participants who fail to attend the Event on March 2-3, 2026, arrive late, or leave early, regardless of the reason, including personal, medical, or travel-related issues.

5.3. Additional Costs: Participants are responsible for all costs not explicitly covered by the ticket price, including but not limited to travel, accommodations, and incidental expenses in Hilton Head Island, South Carolina.
- 6. Photography, Recording, and Publicity**

6.1. Consent to Recording: By purchasing a ticket, Participants grant the Organizer permission to photograph, record, or livestream their likeness, voice, or participation, including during worship services, sermons, or workshops, for promotional, archival, or religious purposes, without compensation.

6.2. No Expectation of Privacy: Participants acknowledge that the Event is a public setting, and they have no expectation of privacy regarding their likeness, voice, or actions during the Event, including during religious services or activities at Providence Presbyterian Church.

6.3. Use of Materials: The Organizer may use photographs, videos, or other recordings of Participants in marketing materials, social media (e.g., posts on X), church publications, or other platforms to promote the Event or confessional Presbyterian values, without further consent or compensation.
- 7. Health and Safety**

7.1. Compliance with Health Protocols: By purchasing a ticket, Participants agree to comply with all health and safety protocols established by the Organizer, Providence Presbyterian Church, or applicable South Carolina or federal laws, including any guidelines in effect on March 2-3, 2026.

7.2. Medical Emergencies:

The Organizer is not responsible for providing medical care or covering medical expenses. Participants are responsible for maintaining their own health insurance and addressing their medical needs.

8. **Data Privacy**
8.1. **Collection of Information:** The Organizer may collect personal information (e.g., name, email, phone number) during ticket purchase or through Event-related platforms, including the Discord server. This information will be used solely for Event purposes and in accordance with applicable privacy laws, including South Carolina and federal regulations.
8.2. **No Liability for Shared Information:** Participants who share personal information (e.g., contact details, accommodation preferences) with other Participants on the Discord server or elsewhere do so at their own risk. The Organizer and Providence Presbyterian Church are not responsible for misuse of shared information or violations of privacy by other Participants or third parties.
8.3. **Discord Privacy:** The Organizer is not liable for any data breaches, privacy violations, or misuse of information shared on the Discord server. By purchasing a ticket, Participants agree to safeguard their own personal information and comply with Discord's terms of service.
9. **Intellectual Property**
9.1. **Event Materials:** All materials provided at the Event, including but not limited to sermons, presentations, handouts, and digital content, are the intellectual property of the Organizer, Providence Presbyterian Church, or their licensors. Participants may not reproduce, distribute, or use these materials for commercial or non-personal purposes without express written permission.
9.2. **Participant Content:** By purchasing a ticket, Participants grant the Organizer and Providence Presbyterian Church a non-exclusive, royalty-free, worldwide license to use any content they submit (e.g., feedback, photos, or comments) for Event-related or religious purposes, including promotion and archiving.
10. **Force Majeure**
10.1. The Organizer and Providence Presbyterian Church are not liable for failure to perform their obligations under these Terms due to events beyond their reasonable control, including but not limited to acts of God, natural disasters (e.g., hurricanes), war, terrorism, strikes, government restrictions, or venue unavailability. In such cases, no refunds or compensation will be provided unless explicitly stated by the Organizer.
11. **Governing Law and Dispute Resolution**
11.1. **Governing Law:** These Terms shall be governed by and construed in accordance with the laws of the State of South Carolina, United States, without regard to its conflict of law principles.
11.2. **Dispute Resolution:** Any disputes arising out of or related to the Event or these Terms shall be resolved through binding arbitration in Hilton Head Island, South Carolina, in accordance with the rules of the American Arbitration Association. Participants waive their right to a jury trial or to participate in a class action lawsuit. The prevailing party in any arbitration or legal action shall be entitled to recover reasonable legal fees and costs.
12. **Miscellaneous**
12.1. **Entire Agreement:** These Terms constitute the entire agreement between the Participant and the Organizer regarding the Event and supersede all prior agreements or understandings, whether written or oral.
12.2. **Severability:** If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
12.3. **No Waiver:** The Organizer's failure to enforce any provision of these Terms shall not constitute a waiver of that

provision or any other provision. 12.4. Assignment: Participants may not assign their ticket or rights under these Terms without the Organizer's prior written consent. You agree to indemnify and hold harmless Presbyterians for the Kingdom Inc., its Board of Trustees, Providence Presbyterian Church, and its Board of Trustees for any claims or liabilities arising from your participation, including those caused by negligence, as outlined in these Terms.
