MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is made and entered into as of _____ by and among the following organizations active in the biomimetic science sector:

WHEREAS, the Parties wish to collaborate in order to advance research and development in the field of biomimetic science and related areas of mutual interest; and

WHEREAS, the Parties wish to establish a framework for cooperation, information sharing, and joint research projects;

NOW, THEREFORE, the Parties agree as follows:

1. Purpose.

The purpose of this MOU is to promote collaboration and joint research among the Parties in the area of biomimetic science and related fields. This collaboration may include, but is not limited to, joint research projects, sharing of data and information, and joint conferences and workshops.

2. Scope of Collaboration.

The Parties will collaborate on research and development projects related to biomimetic science and related fields. The collaboration may include, but is not limited to, the following areas:

- a. Development of biomimetic materials and structures;
- b. Design of biomimetic devices and systems;
- c. Exploration of biomimetic processes and mechanisms;
- d. Study of biomimetic ecosystems and environments;
- e. Investigation of biomimetic approaches to sustainability and resource management.

3. Responsibilities.

Each Party will be responsible for contributing to the collaborative effort as follows:

- a. Providing expertise, resources, and funding as appropriate to support joint research projects and other collaborative activities;

b. Participating in joint research projects and other collaborative activities as agreed upon by the Parties;

c. Sharing data and information related to the collaborative effort as appropriate and in accordance with relevant laws, regulations, and policies.

4. Intellectual Property.

Each Party will retain ownership of its own intellectual property developed or used in connection with the collaborative effort. The Parties will cooperate in good faith to identify and address any issues related to intellectual property that may arise during the collaborative effort.

5. Confidentiality.

The Parties agree to keep confidential any information shared in connection with the collaborative effort that is marked or identified as confidential or that would be reasonably understood to be confidential by a reasonable person.

6. Term and Termination.

This MOU will remain in effect for a period of 3 years, unless terminated earlier by mutual agreement of the Parties. Either Party may terminate this MOU upon 30 days' written notice to the other Party.

7. Amendment.

This MOU may be amended or modified by mutual agreement of the Parties in writing.

8. Governing Law.

This MOU will be governed by and construed in accordance with the laws of Spain.

9. Entire Agreement.

This MOU constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior negotiations, understandings, and agreements between the Parties, whether oral or written.
