### **1. CALL THE MEETING TO ORDER**

The meeting was called to order by Bev White, board chairman @ 8:02 a.m. Board members in attendance were Bev White, Bill Falconer and Mike Glodgett. Kate Wolf, Donna Hatcher and Jane Greenwood were present.

The Dodge has an issue with communication in the wiring harness. This is being worked on but Mike and Geoff will discuss most cost effective repair method.
