This duty to defend, indemnify, and hold harmless shall include the Collaborator's responsibility for any and all foregoing claims, even if such claims are groundless, false, and/or fraudulent and any and all equitable relief, damages, costs and attorney fees except those caused by either the Fairbanks North Star Borough School District's sole negligence or its willful misconduct.

- 2. This obligation shall be continuing in nature and extend beyond the term of this agreement. The doctrine of equitable tolling extends the time within which an action for breach of this provision may be filed.
- 3. "Collaborator" and "Fairbanks North Star Borough School District" as used in this section, include the employees, agents, sub-contractors, and any other persons who are directly employed by or otherwise legally responsible, respectively to each party.

AMENDMENTS
