- With other players only if you choose to interact in public areas We may also share data to comply with legal obligations, protect our rights, investigate misuse, or ensure user/public safety.

5. Data Retention & Deletion

We keep your personal data only as long as needed for the purposes described above or as required by law. Usage data is usually retained for a shorter period unless required for security or legal compliance. You may request deletion of your data by emailing jatribd.com@gmail.com. Approved requests will be processed and your data deleted within 90 days.
