1. Attend Maine Mini Camp (MMC) at **the end of April 2025 TBA**.
2. Attend Local Training - see [Leadership Training Contract](#) for details.
3. Attend National training: National Leadership Training is web based and is required for Seminar participants. Information on a date and time for this training will be provided by CISV National after your application has been selected.
4. Pay the Seminar program fee of **\$TBD** (approximately). Pay for airfare/travel to the Seminar site.
5. Support all other costs of operation such as passport, visa, spending money, emergency money and any other incidentals.
6. If you are accepted, a non-refundable deposit of **\$500 due on TBA**.
7. Volunteer in chapter activities.
