### **NEW & UNFINISHED BUSINESS:**

- Mayor Hogan updated the Common Council on the status of the Southwest Quadrant Water Project. Four bids for the project were opened on Dec. 8; the consulting engineer from LaBella Associates was asked to review them. Mayor Hogan said the issue arose about the city's sole source for sewage pumping equipment, as Smith & Loveless does not specialize in water pumping equipment needed for this project. All bids were rejected, the contract document language will be modified, and the project will be re-bid. Mayor Hogan said he is confident the new bid will result in a lower overall bid that will be well within budget.
- Mayor Hogan reported that he met last week with Gov. George Pataki and 14 other mayors in Albany. The governor outlined what Mayor Hogan said was going to be a "very difficult" state budget, as New York State is out of balance an estimated \$4 billion to \$6 billion, not including court-ordered increased aid to education. Gov. Pataki is looking at a "reform budget," according to Mayor Hogan, with results-based funding initiatives and the mayors were asked for their input. "We felt it was a productive meeting," said Mayor Hogan, who will attend the State of the State speech on Jan. 5, 2005.
- Mayor Hogan told aldermen that Gov. George Pataki's veto of a bill outlawing plastic piping now brings New York State's Uniform Code closer to those in other states.
- There is nothing new to report on the pension fund problems, Mayor Hogan said. The City of Hornell's pension premiums have risen from \$40,000 to \$700,000. The mayor said he hoped a resolution would be forthcoming on the issue.
- Mayor Hogan said it is "a fluid situation" with Steuben Tile, the company in Shawmut Industrial Park that recently closed. The mayor said he has received calls from people interested in bringing the company to full production.
- Recent state equalization rate numbers indicate a strong housing market in Hornell, according to Mayor Hogan. The City of Hornell traditionally has had an equalization rate of about 100 percent, meaning houses are selling close to their assessed value. However, Mayor Hogan said the latest equalization rate in Hornell is down to 80 percent, "which shows values shot up significantly." City Attorney Pelych added that sale of single-family homes is primarily responsible for the new equalization rate.
