

LIABILITY RELEASE AND INDEMNIFICATION FORM FOR MINOR TRAVEL

I, the undersigned participant and parent request voluntary participation for the minor to travel to and from swimming events with RAC SWIMMING.

I consent to my/minor's participation in traveling to and from swimming events and acknowledge that I fully understand my/minor's participation in travel may involve risk of serious injury or death, including losses which may result not only from my/minor's own actions, inactions or negligence, but also from the actions, inactions, or negligence of others. This includes all travel to and from the event arranged by RAC SWIMMING, including but not limited to all transportation being plane, boat, train, van, car, airline, and/or chartered plane paid either by the participant or travel paid or reimbursed by RAC SWIMMING. I understand that if I have any risk concerns regarding travel, I should discuss the risks associated with my/minor's participation with the coach and RAC staff before I sign this document and before travel begins.

Release - Minor's Rights: In consideration of allowing Minor Participant to travel to and from swimming events, I hereby release and hold harmless RAC SWIMMING, members of its board of directors, and its officers, employees, members, volunteers, other participants, and agents (collectively, the "Released Parties"), of and from, and do discharge and waive, any and all claims, demands, losses, damages, and liabilities that Minor Participant may have or sustain with respect to any and all damage and/or injury, of any type, arising out of his or her travel to swimming events. I also agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
