

**Thank you for helping to uplift Kawaski Trawick's family's demands that:**

- **Mayor Adams and Commissioner Caban REJECT the draft recommendation from Deputy Commissioner Rosemarie Maldonado (who oversaw the discipline trial) and, instead, fire NYPD Officers Brendan Thompson and Herbert Davis for killing Kawaski.**
- **Mayor Adams meets with the Trawick family and their team before a final decision about discipline for Thompson and Davis is made.**

Kawaski Trawick was a Black gay man, a son, and a brother, who was pursuing his dreams as a dancer in New York City. On April 14, 2019, NYPD Officers Brendan Thompson and Herbert Davis illegally entered Kawaski's home and killed him.

In June 2021, after the NYPD refused to bring discipline charges, the Civilian Complaint Review Board voted to substantiate fireable charges against both officers. After years of delays, cover-ups and obstruction by the NYPD, Thompson and Davis, and their police union attorneys, an NYPD discipline trial was held for both officers in spring 2023. In late September, it was revealed that an internal draft NYPD report was recommending that all charges against Thompson and Davis be dropped - blaming the CCRB for the NYPD's delays.





8 facts about the NYPD killing of

**KAWASKI  
TRAWICK**

1. Kawaski was just cooking in his apartment.
2. Officers Brendan Thompson & Herbert Davis illegally entered Kawaski's apartment. Davis used his baton to break the chain holding Kawaski's door closed.
3. Thompson & Davis were CIT-trained but refused to answer Kawaski's questions & created a crisis.
4. There was no emergency to justify Thompson & Davis' illegal entry or escalations.
5. Thompson tased Kawaski for no reason, then shot 4 times. They killed Kawaski in 112 seconds.
6. After Kawaski was shot, neither officer rendered aid. Davis shut the door & they let Kawaski bleed out.
7. NYPD refused to release names of cops when Kawaski was killed. They hid the full video for 20 months.
8. It's been 4 years of delays & obstruction under 2 mayors & 4 police commissioners.
