## **Introduction**

Your text is here, in 12-pt Times New Roman font, left, right, top, and bottom margins are 3 cm on A4-sized paper; 1.5 line-spacing; don't add space before and/or after paragraph; length: between 5,000 and 8,000 words (including abstract, references, and footnotes). It is much better to not format your text in a specific technique, instead, just leave it plain except that you really need to type certain words in a "special method", or to emphasize certain word or words. Italic is a must in typing non-English word.

The introduction section, comprising approximately 15–20% of the total manuscript length, must clearly articulate the purpose of the study. It should provide the background of the issue, a state-of-the-art review, and cite at least five relevant articles from reputable international or accredited journals published within the last ten years. The introduction must also include a gap analysis in relation to prior studies, highlight the novelty of the research, and clearly present the research objectives. ## **Findings and Discussion**

This section should present a clear explanation of the research findings by addressing what was discovered and how it was analyzed. It should also explore the relevance of these findings in relation to existing concepts or theories, explaining why they matter. Additionally, the discussion must include a critical comparison with previous studies, highlighting whether the current results support, refine, or challenge earlier research (what else is contributed).

## **In-Text Citations**

The citations and references should follow the style of Chicago Manual of Style 17th Edition (full note). Every source cited in the body of the article should appear in the References, and all sources appearing in the References should be cited in the body of the article. Use *Reference Management Software* such as Mendeley

(<https://www.mendeley.com>), to manage the references for your paper. Use other published articles in the same journal as models.

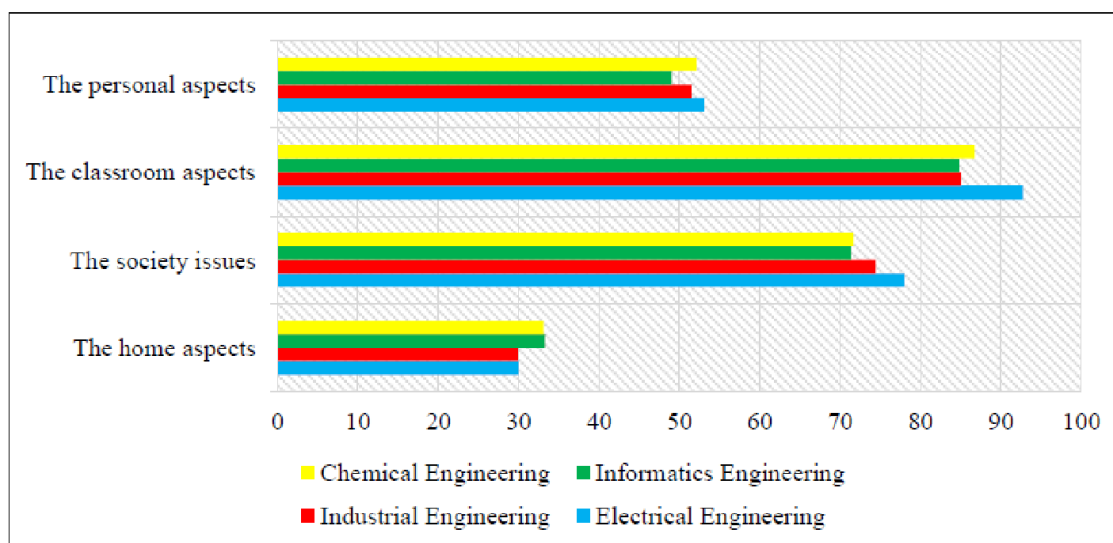


Figure 1. Title of the figure
