1. Introduction [Cambria 11pt bold]

Introduction includes, among other things, the background to the problem, the gap between the idealized and the real, supported by the latest relevant theories and research on the problem, and the new value of research which is innovation. This section is written up to a maximum of 20% of the article body. Literature sources are highly recommended from primary sources (articles).

This section is supported by a literature review which is used as a support for the concept of service. Authors are required to present primary and up-to-date literature reviews (references to journal articles and conference proceedings) (references published within the last 5 years). Literature review is not limited to theory, but also empirical evidence. Enrich this introductory section with the efforts that have been made by other parties. [Cambria 11pt]

2. Methods [Cambria 11pt bold]

In the application method section, describe clearly and concisely the method used to achieve the goals set in the community service activities. The results of the service must be measurable and the authors were asked to explain the measuring instruments used, both descriptively and qualitatively, with the time and schedule of the activities carried out. Explain how to measure the level of achievement of the success of community service activities. The level of achievement can be seen from the attitude, socio-cultural and economic changes of the target community. This section is written up to a maximum of 10% (for qualitative research) or a maximum of 15% (for quantitative research) of the body of the article. [Cambria 11 pt]

3. Findings and Discussions [Cambria 11pt bold]

To facilitate understanding and reading, the research results are described first, followed by the discussion section. The results subtitle and the discussion subtitle are

presented separately. This section must be the most numerous, at least 60% of the entire body of the article.

Results can be presented in the form of tables of figures, graphs, verbal descriptions, or a combination of the three. Tables, graphs, or images shouldn't be too long, too large, or too many. Writers should use variations in the presentation of tables, graphics, or verbal descriptions. The tables and graphs presented must be referred to in the text. The way of writing tables is shown in Table 1. The table does not contain vertical (upright) lines and horizontal (flat) lines only in the head and tail of the table. Tables and figures can be reduced in font size. [Cambria 11 pt]

The discussion is intended to interpret the research results according to the theory used and not just to explain the findings. The discussion must be enriched by referring to the results of previous studies that have been published in scientific journals.

Writing references in the body of the article uses the bracketed pattern (). If there is only one author: example (Retnowati, 2018); if there are two authors: example (Nurgiyantoro & Efendi, 2017). If there are two to five authors, for the first mention all are written: examples (Retnowati, Fathoni, & Chen, 2018) and the next mention is written (Retnowati et al., 2018). Authors of more than three people are written only by the first author followed by et al., for example (Janssen et al.' 2010). It is recommended that referrals are not in the form of direct quotations or do not contain too many direct quotations.

Images included in the manuscript must be of good quality. Images do not stand alone and must form a relevant part of the text. Please note that the images are not documentation that is not related to the discussion of the manuscript. Make sure the manuscript does not display images that show the identity or affiliation of the authors

If a statement is extracted from several references, all sources are written by mentioning all references in alphabetical order and a semicolon (;) to separate sources, for example (Sahlberg, 2012; Schunk, 2012; Retnowati, Fathoni, & Chen, 2018).

4. Conclusion [Cambria 11 pt bold]

Conclusions are not just repeating data, but in the form of meaningful substance. It can be in the form of a statement about what is expected, as stated in the "introduction" chapter which can finally produce a "results and discussion" chapter so that there is compatibility. In addition, prospects for developing research results and prospects for further research applications in the future (based on results and discussion) can also be added. [Cambria 11 pt].

Bibliography is sorted alphabetically (Mandatory Use of **Mendeley** or other electronic reference applications). Everything referred to in the article must be written in the bibliography and everything written in the bibliography must be referred to in the article. [Cambria 11 pt]. The bibliography writing format uses **APA 6TH Editions**
