Former president Banks' retirement comes after a flurry of national media attention concerning the failed hiring of Dr. Kathleen

decisions sparking outcry from students; both current and former. ²³⁴; and

Whereas(3): In the last two years current students have felt underrepresented in decisions made

by administration, and oftentimes the decisions made seem to directly conflict

with current student opinions,; and, ⁵

Whereas(4): A&M, like many land grant institutions, is responsible to a variety of stakeholders

with often conflicting visions for the university's future. However, most decisions affect the current student body and they are often consulted after the decision has

been made public; and,

will be a national search spanning multiple months to determine the next president

of Texas A&M University; and,
