

TERMS OF SERVICE

By commissioning me, you are agreeing to the following terms and conditions:

General

- Terms of Service and Prices are subject to change at anytime. You're only subjecting to the ToS and prices agreed upon at the time of the transaction.
- I reserve the right to reject a commission with stating a reason or not.
- All artwork is transferred digitally.
- I am still acquiring skills and may have some limitations that may affect my performance. I'm open to try new things, if you willing to commission me something out of my skill at that moment.

Payment

Payments are done through PayPal in PLN. I require $\frac{3}{10}$ of payment before starting a commission. Once I accept your commission, I will send an notice due in max 5 days that I've accepted your commison. Once the invoice is paid, I will start your commission. If the invoice is not paid, I will have to cancel the commission.

Commission for Commercial Use

A Purchase of Commercial rights to the artwork will always be 300% of original price. With commercial rights you are allowed to make any sort of merch with the artwork. Use it in books, covers, prints, ect., you can edit it and promote your own brand with. Credit is still required for usage of the artwork, even if altered or edited.

Deadlines

Depending on my workload and type of commission, after the description of the commission I'll be able to estimate time of making it. I will provide an estimate time for completion, and/or indicate if there is a delay in completing your commission. You may request a WIP at any time. But if you need work done before certain date be sure to say it before I'll start working on commision.

CUSTOMER SATISFACTION

I want to make my customers happy and satisfied with my work.
However after a commission is finished, only small changes are allowed to be made. Colouring/markings mistakes.

Any great changes will come with an extra charge.
Such as an outfit change, outfit addition or subtraction, background change or anything that makes me have to redraw it completely.

If your reference was unclear to start with, then you are not allowed to do minor changes without a fee.
Make sure to be clear in your order what you aim for. And naturally I'll tell you how much it will cost additionally.

Usage Policy/Copyright

My artwork is for personal use only. No commercial use of my artwork is allowed

If you would like your commission to be private, please let me know!¹

The commissioner are allowed to:

- ▶ Use the copyrighted artwork for personal use only, unless agreed otherwise.
- ▶ Print the art, and claim the right of their character(s) but not the drawing itself.
- ▶ Use the art to promote themselves with proper credit given to the artist.

If you break the copyright infringement in any way, every right you had to the drawing will be retracted.

The following is considered Copyright infringement:

- ➡ Reproducing/using the copyrighted artwork commercially. (Meaning making money from my non-commercial work.)
 - ➡ Taking Credit for the creation of the artwork.
 - ➡ Removing any watermarks/signatures.
 - ➡ Altering the artwork without my consent.

I forbid from making NFT's and putting my art through AI programs to generate other pictures.
