December 6, 2023 Board Minutes

The Organizational Meeting was called to order on December 6, 2023 at 5:00 pm with Lori McClenathan as president pro tem.

The Oath of Office was administered to new members, David Doran, Maria Hawkins, and Blake Kuesel.

Kupka nominated David Doran as President, results of the vote were 4 ayes, 0 nayes. The Oath of Office was administered to Doran.

President Doran call for nominations for Vice President. Henning nominated Kupka, results of the vote were 4 ayes, 0 nayes. The Oath of Office was administered to Kupka.

Lori McClenathan was appointed Board Secretary/Treasurer for the 2023- 2024 year.

Motion by Kuesel to approve official depositories for 2023-2024, Chelsea Savings Bank for \$1,000,000, Keystone Savings Bank for \$6,000,000 and Green State Bank for \$1,500,000, seconded by Hawkins, 3 ayes, 1 naye.

Motion by Hawkins to approve the certified negotiations team of Doran and Henning, non-certified Kupka and Hawkins, Kuesel will be alternate Henning, unanimously adopted.

Henning was appointed to Poweshiek County Conference Board, Kupka was appointed to the Iowa County Conference Board.

There was a review of Board Policy 705.3.

There was a discussion on the 2024 invoice review procedures.

Financial statements were reviewed.
