

EVENT WAIVER – RELEASE OF LIABILITY

This Release of Liability and Event Agreement (“Agreement”) is entered into on the date of signing by the Event Attendee (“Participant”), and by and between Com2uS Taiwan Ltd. (“Company”). The Participant understands and agrees they are entering into a legally binding Agreement with Company, inclusive of the following terms and conditions mutually agreed upon once the Participant signs this agreement. For good and valuable consideration outlined below, Participant is electing to attend “10th Anniversary Celebration for MLB 9 Innings” (“Event”).

Voluntary Participation

The Participant acknowledges that their decision to attend the Event is purely voluntary and that any negative experiences before, during, or after the Event are not the fault or responsibility of the Company or any of the MLB Entities. The Company and the MLB Entities did not force or personally advise the Participant to attend and the Participant has made the decision to attend based on their own assessment of the circumstances. As such, the Participant will not hold the Company, the MLB Entities or any of their affiliates, employees, owners, or contractors responsible for any injury, issue, or negative experience that may occur as a result of their attendance at the Event or during any part of their travel to and from the Event.

Food and Beverage

Company may provide appropriate food and drinks depending on the length and timing of Event, as Company sees fit throughout the duration of Event.

The Company will make a reasonable effort to label food and drink options to identify any potential allergens, but cannot guarantee the accuracy or completeness of all food warnings. If the Participant has any food allergies, intolerances, or special needs, they will use their own judgment to determine if the food and drinks are suitable for consumption and use common sense in making decisions while at the Event. The Company will make an effort to provide meal and drink options that meet common dietary restrictions, but it may not always be possible to accommodate every restriction and there may be some meals or parts of meals that do not comply with the Participant's restrictions. The Participant takes full responsibility for choosing what to eat at the Event, if anything, and acknowledges that the Company, the MLB Entities, and their employees, owners, affiliates, or contractors are not responsible for any health-related issues that may occur as a result of the food or drinks consumed at the Event, whether due to a known or unknown cause, or whether the food was appropriately labeled or not.

Alcohol and Drugs

The Company may provide limited alcoholic beverages to each Participant. Alternatively, if a Participant does not wish to receive their alcoholic beverage, they may receive a regular beverage instead. The consumption of alcohol must comply with the relevant government laws and regulations of the country in which the event is being held. The consumption of alcohol at the event is at the Participant's own risk. Excessive consumption of alcohol and all violent or inappropriate behavior will not be tolerated. If a Participant exhibits such behavior, in Company's sole and absolute discretion, Company may remove Participant from the Event. Participant hereby acknowledges that Company and the MLB Entities are not responsible for guaranteeing appropriate behavior by other participants of the Event, and Participant hereby

accepts all known and unknown risks associated with such behavior being exhibited by other participants at the Event. Company, the MLB Entities, and their affiliated entities will not be held liable for any harm or injury resulting from the consumption of alcohol, including but not limited to accidents, injuries, or damages to property or person. The Participant understands that the consumption of alcohol may impair their judgment, coordination, and motor skills, and may increase the risk of accidents or injuries. Therefore, the Participant agrees to consume alcohol responsibly and to not operate a motor vehicle or engage in any hazardous activity while under the influence of alcohol.

The use or possession of illegal drugs is strictly prohibited during the event and will not be tolerated under any circumstances. Participants found to be in possession of or using illegal drugs will be immediately removed from the event without exception. The event host, its affiliates, and all other related entities take the issue of illegal drug use very seriously and will take all necessary and appropriate steps to ensure a safe and secure environment for all participants. The event host and the MLB Entities do not assume any liability for harm or injury resulting from the use or possession of illegal drugs by any participant. Participants acknowledge and accept all known and unknown risks associated with such behavior and agree to indemnify and hold harmless the event host, the MLB Entities, and their affiliates for any claims, damages, or expenses arising from their actions.

Photo/Media Release

Participant understands and agrees that Event will likely be filmed, recorded, and/or documented by photographers, media, or other members of the press. The Participant recognizes that they may appear in these recordings, photographs, or documentation and voluntarily grants the Company and the MLB Entities a royalty-free license to use their name, image, and likeness in these recordings, photographs, or documentation for commercial purposes. This usage may include but is not limited to the publication of the images and recordings on the Company's or the MLB Entities' website and social media platforms (such as Facebook, Instagram, Twitter, etc.). The Company and the MLB Entities may also transfer or assign these rights to third-party entities. By accepting the terms of this Waiver and completing the registration process for the event through Eventbrite, the Participant provides the Company and the MLB Entities with an unrestricted and irrevocable release for the use of their name, image, and likeness, and all associated recordings or photographs, in any manner deemed appropriate by the Company or the MLB Entities.

Participant understands and agrees that other Event attendees and presenters may have recording devices, including cell phones, laptops, and other means of capturing footage, photos, and audio, which they may share online through social media platforms. Participant acknowledges that attendees have the right to do so. Participant acknowledges and agrees that he/she may be captured in photographs, videos, and other recordings, either in the foreground or background, and that these images or videos may be shared by those who record them. Participant agrees to indemnify and hold harmless Company, the MLB Entities, and their affiliates from any claims arising from the posting or broadcasting of any photographs or media that depict Participant, whether intentional or unintentional. The Company and the MLB Entities are not responsible for what attendees may post and Participant acknowledges that he/she is attending the Event

voluntarily and assumes all risks associated with being recorded by Event staff, attendees, guest experts, speakers, and/or Company.

For purposes of this Agreement, the “MLB Entities” shall be defined as Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“MLB”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“Clubs”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities.

I, PARTICIPANT, have read the foregoing waiver and release, and voluntarily agree to the terms as written, with full knowledge of its content and meaning. I understand this Waiver is being agreed to in addition to and in accordance with any additional Agreements between myself and Company.
