- i. Special Education Deficit-Modified Allowable Growth Request For the fiscal year 2025 we had a deficit of **\$144,661.54** in special education. State law allows us to request to gain back this spending authority through a Modified Allowable Growth Request. Spending authority is critical for the district and I recommend that you authorize me to request this from the SBRC. It allows us to levy property taxes as part of our next budget to fund the deficit. The reason for this provision in Iowa Code is to ensure that districts meet the needs of their special needs students without the fear of losing spending authority.
