Jamal Brown, athletic director and boys basketball coach, reported that FTHS just finished winter season for sports. 3 of the 5 winter sports made it to CIF playoffs. 8 spring sports have started. This year FTHS added Beach Volleyball which is now an official CIF sport. Spectators can now attend indoor sports (such as volleyball) mask-free. He invited all parents to come and check out a game.

Shannon Van Wagner, from the special ed department, reported that it has been a busy year. There are 2.5 staff members for the special ed program. This year there is a new psychologist and new speech pathologist, plus 3 paraprofessionals, which represents a significant growth in staff. This has enabled them to increase study skills class to 3. There has also been an increase in the number of students. The special ed program at FTHS supports students with learning disabilities, physical disabilities, and autism.

Principal's Report

This was a big week, as it was the first week where no masks are required on campus. Some kids have chosen to keep wearing a mask, and others are going without. Students and staffulty are respecting each other's choices. So far, no issues.

Last week, FTHS held a senior recognition awards ceremony. The whole senior class was able to be in Spirito Hall for the first time since before the pandemic. This event marks the beginning of the end of the year for seniors.

Prom is coming up, as well as a Renaissance celebration with an Alice in Wonderland theme. Principal Gibbs and Jamal Brown will sit in the dunk chair on Friday.

Schedule building for 2022-23 school year has begun. And planning for graduation has kicked off.

Ophelia reached out to Kerry and they did an Amazon Smile transfer to her. Amazon Smile is set up associated with Darcy Duffy's email. Need to reset it up. \$500 collected YTD through this channel.

Boosters

Shontaia was not in attendance, but Denise Bishop, President, was at the meeting. She stated that the boosters only raised \$4,500 this year vs. \$6,200 raised last year. With the pandemic restrictions easing, they are considering going back to an alternative fundraising approach, perhaps an in person golf tournament. They are working through a change to the way they allocate funds to each team. Rather than paying for tournaments, etc, each team will now get funds put into their account, which they can fundraise for. These funds can be used for banners, coaches uniforms and development, equipment maintenance and supplies, insurance, etc.

Jen set up the staff workroom for St. Patrick's Day and provided green themed items for teachers for March appreciation.

Jen suggested we provide shirts to faculty in the budget going forward. If we want to start this year, we need to update our budget. Barbara, made a motion to increase the budget by \$1000 for teacher appreciation to buy the staff shirts this year.

Next year's board can discuss whether to put ongoing funds into the budget for staff shirts going forward.

OLD BUSINESS

1. Surplus Reserves in PFSO account:

Kimberly shared the progress and approach we will be taking to determine how to spend our cash surplus. A short list of options has been created and the sub-committee is researching viability and costs of each.

NEW BUSINESS

1. Sprigeo – Barbara Beltran-Walker

Sprigeo allows students to anonymously report bullying, harassment, drugs, harming themselves, etc. Barbara asked that the school push and communicate about this tool. Including putting posters in each room, have faculty review them regularly.

Mr. Gibbs indicated that VUSD does not have a license for the software. Would need to work with student services to get access.

At Balboa when there were issues, they put a link onto a form on the website that can be sent by email to the admin as an alternative that is free and possibly faster to get implemented.
