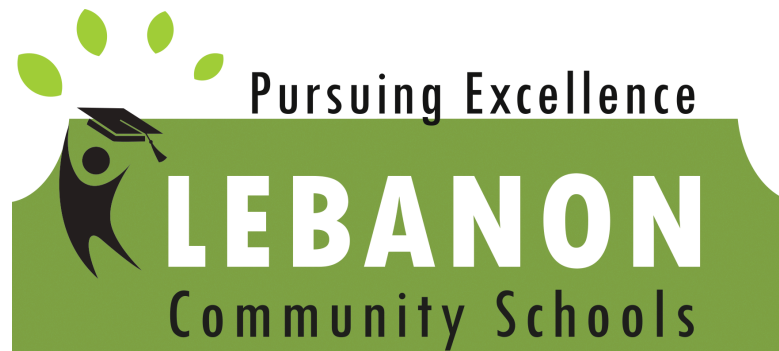

SECTION 1. Clarifying Roles and Responsibilities

Identifying roles central to communicable disease management. Clarifying responsibilities related to communicable disease response is a first step in keeping communities healthy and safe. In general, decisions of school health and safety reside with school and district officials. Together with local public health officials, school/district administrators should consult a variety of individuals when making decisions about health and safety in school.

Section 2. Equity and Continuity of Education

OHA/ODE Recommendation(s)	Response:
Describe how you will ensure continuity of instruction for students who may miss school due to illness.	Our schools have access to Canvas and Google Classroom as Learning Management Systems. Students without access to devices at home may check out Chromebooks from their school libraries. Since COVID, we have partnered with PEAK to improve the reach of the internet in our rural areas, and we have hot spots available to lend. These platforms, tools, and services, combined with ParentSquare, which facilitates efficient dialogue with parents, ensures that students can continue to access and engage with instruction, and parents can stay informed and supported in assisting their children.
Describe how you identify those in your school setting that are disproportionately impacted by communicable disease and which students and families may need differentiated or additional support.	We monitor attendance data to identify individuals struggling with absences due to illness as well as demographic trends and family patterns. Our administrators, educators, health room assistants, and district nurses communicate to align information, practices, and responses and to ensure we are operating in an equitable, culturally-sensitive manner.
Describe the process by which the school will implement a differentiated plan for those that are disproportionately impacted, historically underserved or at higher risk of negative impacts or complications related to communicable disease.	We routinely create individualized plans to support students and their families. The staff, systems, (Multi-tiered Systems of Support, technology supports, language tools, etc.) and resources (e.g., Welcome Center) we have in place help ensure that those at higher risk of negative impacts due to absences are supported during their illness and after their return. We tailor our support based on each student's situation and respond nimbly based on the circumstances; however, our MTSS system typically drives the steps and scope of our response.
Describe what support, training or logistics need to be in place to ensure that the named strategies are understood, implemented, and monitored successfully.	We have monthly training for staff to increase awareness and dialogue around supporting our focal groups. Our early-release Wednesdays also provide time for school teams to conduct MTSS meetings to discuss students struggling and needing additional support. All staff are provided resources and training to ensure they can identify and address concerns in a way that is aligned with policy and centers on equity for our students and their families.



Section 3. Communicable Disease Outbreak Prevention and Response:

Implementing mitigation activities, responding to periods of increased transmission, resuming baseline level mitigation, and debriefing actions to improve the process

Planning for and implementing proactive health and safety mitigation measures assists schools in reducing communicable disease transmission within the school environment for students, staff, and community members. Communicable disease, including norovirus, flu and COVID-19, will continue to circulate in our communities and our schools. Schools will utilize different mitigation measures based on local data, and observation of what is happening in their schools (e.g., transmission within their facilities and communities.) In the following section, teams will document their school's approach to the CDC, OHA and ODE advised health and safety measures at baseline, during increased transmission.

Communicable Disease Mitigation Measures

OHA/ODE Recommendation(s) Layered Health and Safety Measures	Describe what mitigating measures the school will implement to reduce and respond to the spread of communicable disease and protect in-person instruction?
Immunizations	<i>CDC, OHA, and ODE recommend COVID-19 vaccination for all eligible individuals. Please include whether your school will offer COVID-19 vaccine clinics or notices about where to access vaccines in your community. Shots are required by law for children in attendance at public and private schools, preschools, child care facilities, and Head Start programs in Oregon. Nearly every place that provides care for a child outside the home requires shots or a medical or nonmedical exemption to stay enrolled.</i> We will not offer vaccine clinics or notices about vaccine locations. Our Events & Opportunities page may post relevant flyers if OHA provides them.
Face Coverings	We have masks available upon request. Students and staff may choose to wear masks at school and school-sponsored events as a personal prevention measure.
Isolation	As needed, we may isolate students based on symptoms indicated on our Health Services page. Students isolated must be picked up from school by a parent or guardian.
Symptom Screening	In our health rooms, staff may engage in symptom screening as indicated on the table on our Health Services page.
COVID-19 Diagnostic Testing	<i>OHA offers schools a diagnostic testing program to all public and private K-12 schools in Oregon. Please indicate whether your school will offer diagnostic testing.</i> We will offer diagnostic testing only upon parent/guardian request and as long as OHA supplies tests to our district.
Airflow and Circulation	The Oregon Health Authority has provided air purifiers for all classrooms and offices across our district; these will improve airflow and circulation throughout our facilities.
Cohorting	We are not implementing cohorting as of Fall 2023 but will adjust based on state guidance.
Physical Distancing	We are not implementing physical distancing as of Fall 2023 but will adjust based on state guidance.

OHA/ODE Recommendation(s) Layered Health and Safety Measures	Describe what mitigating measures the school will implement to reduce and respond to the spread of communicable disease and protect in-person instruction?
Hand Washing	We have hand washing reminders in restrooms and public spaces and will reteach, especially at lower grades, as necessary. Our district purchased hand sanitizer for all classrooms this year so that educators and students can supplement their hand washing and apply it as a prevention measure prior to meal times.
Cleaning and Disinfection	Our custodial team engages in daily cleaning and disinfection. Our district purchased disinfecting wipes for all classrooms this year so that staff and students may clean desks and other surfaces as needed throughout the day or with increasing frequency during heightened communicable disease spread.
Training and Public Health Education	Based on advice from our district nurses and guidance from the Oregon Department of Education and the Oregon Health Authority, we will train staff on current conditions and response and will inform our constituents if that training has the possibility of impacting students en masse. This approved plan will be added to our website, as will more up to date information and instructions should a communicable disease event interrupt or alter our operations.

Training exercises are essential to preparedness ensuring individuals understand their role in a communicable disease event. Exercises can also help identify gaps in the planning, thereby building upon and strengthening the plan over time. Schools, districts, and ESDs should schedule to exercise this plan annually and when any revisions are made to update the plan. The plan, or component(s) of the plan, can be tested through conversations, practice exercises, or other activities.
