6. Insurance and Liability

Each party shall be responsible for its own liability and insurance coverage. The Organizer assumes no responsibility for any loss or damage caused by the Sponsor's representatives, materials, or activities.

7. Termination

Either party may terminate this Agreement in writing if:

- The other party breaches any material term and fails to cure within 10 days
- Circumstances beyond either party's control make the event impossible to hold

Upon termination, Organizer will refund any unused portion of the sponsorship fee, unless termination is due to Sponsor's breach.
