Privacy Policy

This privacy policy ("Privacy Policy") describes what information Joseires ("Developer" or "We") collects, why we collect it and what we do with it in running our mobile wallpaper application ("Mobile App"). We refer to our Mobile App users as users ("Users") of our Service ("Service").

Please read this policy carefully. By continuing to use the Service, you agree that you have read and are bound by this policy. If you do not agree to this policy, you must not use the Mobile App.

- 1. What information do we collect from you?
- 1.1 We may obtain non-personally identifiable information from you. Non-personally identifiable information is information that usually cannot by itself be used to identify a particular person or entity, and may include: the Internet Protocol (IP) address, unique device identifiers, operating system, mobile network information, browser type, browsing and/or downloading activity and non-precise device location information.
- 1.2 We may also obtain certain personally identifiable information when you visit our Mobile App, view any content, upload wallpaper and/or download any wallpaper or themes. In particular, for example, when you upload your wallpaper to our Mobile App, we may obtain your nickname and email address. When we receive any email from you, we may obtain your name and email address as well. Some of that information can be used by us to identify or contact you directly and is sometimes referred to as personally identifiable information.
- 1.3 When you access the Services on your wireless device, we may obtain information from your wireless carrier about the type of device you are using. We may use this information to notify you about what type of features and products from us may be available to you on your device.
- 1.4 We may use a number of cookies to collect non-personal information for many purposes. Please note that by using the Services you are consenting to the use of cookies.
- 2. How do we use your information?
- 2.1 We use the information obtained or collected from you on the Services to:
- analyze trends and preference;

- create statistical data in analyzing user behavior;
- tailor the wallpapers and themes according to your preference;
- develop new content and function of our Mobile App;
- provide advertisement across the Service;
- •improve user experience;
- respond to use inquiry and complaints;
- maintain and streamline our services; and
- •monitor compliance with the rules and laws governing the Service.

We don't sell your personally identifiable information to third parties.

- 2.2 We may share non-personally-identifying information with third parties, including but not limited to advertisers, consulting companies, analytic providers or investors, for the purpose of conducting business.
- 3. What are the advertisement on our Mobile App?
- 3.1 We use third-party advertising companies to serve ads when you visit the Mobile App. These companies may use information about your visits to any of the websites and other mobile applications in order to provide advertisements about goods and services of interest to you.
- 3.2 We assume no responsibility or endorsement for the service and content of those websites and mobile applications and we will not be liable for any loss or damage that may arise from your visit or purchase if any. Further, in order to facilitate the purchase of any goods, content and/or service, our advertisers and their partners may collect additional information. Please note that this information may be used in accordance with the advertiser's privacy policy, which may be different from our Privacy Policy.
- 3.3 For clarity, subject to the above, the treatment of your information by any third parties linked with or within our Service are not applicable by this Private Policy.
- 4. To whom we may disclose information?
- 4.1 As reasonably necessary to provide Service to you, we may share non-personally identifying information or personally identifying information with our partners or affiliates.

- 4.2 We may disclose your information to third parties when obligated or permitted to do so by law and in order to investigate, prevent, or take action regarding suspected, or actual prohibited activities, including but not limited to fraud and situations involving potential threats to the physical safety of any person. We reserve the right to disclose to third parties non-personally identifiable information collected for any lawful purpose.
- 4.3 We may transfer information, including any personally identifiable information, to a successor entity (or potential buyer) in connection with a corporate merger, consolidation, sale of assets, bankruptcy, or other corporate change.
- 5. Do we have security measure with our Mobile App?
- 5.1 We use reasonable electronic, personnel, physical and administrative measures to protect information from loss, theft, alteration, leakage, tamper, damage or misuse in accordance with the requirement of the relevant laws, industry standards and rules.
- 5.2 It is understood that even the best security measures cannot fully eliminate all risks. We cannot guarantee that only authorized persons will view your information. We are not responsible for third party circumvention of any privacy settings or security measures.
- 6. How long will we possess your information?
- 6.1 We may destroy the user's personal information immediately when the purpose of the collection and use of your information is achieved. However, in case to comply with the relevant laws and regulations in different jurisdictions, your information may be stored for a period of time based on the local law.
- 7. What if we change our Privacy Policy?
- 7.1 We may, in our sole discretion, change this Privacy Policy from time to time. Any and all changes to this Privacy Policy will be reflected here and the date new versions are posted will be stated at the top of this Privacy Policy.
