**NOTICE OF
ACCESSIBILITY**

Further Notice is given that, where a regular polling place has limited accessibility, a disabled or elderly voter may be provided an alternate means of casting his or her ballot. Such means may include reassignment to an accessible polling place, curbside voting, assisted voting or voting by absentee ballot. A voter may apply for an absentee ballot in person or by mail, or may have a relative or guardian apply in person on his or her behalf. If a voter is permanently disabled, he or she may have the notary requirement for the absentee balloting waived by filing a physician's statement concerning the disability. In addition, voters requiring assistance may be assisted by a person of the voter's choice.
