TERMS USED

And their definitions

Paralaw

It is the body of law related to the Veil. It includes both the organic laws that establish and define the Veil and consensus normalcy, as well as specific regulations and proscriptions meant to enforce and maintain the Veil. While secret in its implementation, paralaw is not secret law . The most important articles of paralaw are incorporated into the public law, albeit in an opaque or obscure manner that does not betray the existence of the Veil.

Veil

It is an international consensus to conceal from the general public the existence of certain inexplicable and unconventional phenomena which defy the natural order as it is commonly and currently understood. These phenomena are variously deemed paranormal, esoteric, occult, paranatural, and/or anomalous; the effort to conceal them is known as the Veil.

TYPES OF PARALAW

Paralaw can be broadly divided into two fields, classified by the spheres in which it operates.

Personal paralaw is only applicable to individuals and entities operating behind the **Veil**. It encompasses a wide range of criminal, regulatory, and civil law, with the intention of policing paranormal communities so that they do not disrupt consensus normalcy.

General paralaw mainly applies to individuals not privy to the **Veil**, and is aimed at the maintenance of consensus normalcy. Most powers to control the movement of persons, goods, and information in relation to the Veil are derived from general paralaw.

ARTICLE V

PERSONAL PARALAW

(The ITD does not conduct cases pertaining to this article. All alleged criminals and case materials are directed to the GOC for legal proceedings in accordance with UN Secret Convention №76)

§ 5.1 The Foundation pledges from the signing of this treaty to no longer transport anomalies to the Surface for the following reasons:

Intent of using the anomaly for weaponized means on the Surface

Transporting the anomaly to a Surface zone that has risk of encounter with Civilian populace

ADDENDUM: If containment/veil is at risk of failing, Foundation is to call GOC QRF to assist in the re-establishment of containment and protection of the veil. If containment/veil has already failed, GOC has full authority to immediately deploy and resecure the anomaly and return it to the Foundation.

Should the GOC recover an anomaly of the Foundation's in the wild due to containment failures, the GOC have full authority to take the anomaly to their base temporarily for study and research purposes but CANNOT terminate it, for 3 days (OOC: 30 minutes IRL time if the SCP wishes to leave. 1 hour absolute maximum if they consent to staying longer).

§ 5.9 Withholding or falsely reporting information regarding properties of anomalous object against the GOC or SCP Foundation where information of the anomalous object is not inherently dangerous

§ 5.10 Collaboration with GoI from the list of outlawed organisations (see UN Secret Convention №76 Addendum №2)

§ 5.11 Withholding or falsely reporting information leading to misallocation of assets against the GOC or SCP Foundation

§ 5.12 Armed conduct against non-combatants where there is no threat to the GOC or the SCP Foundation's missions and all other options have not been exhausted, where internal judicial proceedings of either faction have failed to provide fair settlement to the incident

§ 5.13 Armed conduct or intimidation against diplomatic teams or envoys

§ 5.14 Causing undue harm to prisoner(s) of war via neglect or intentional actions

GENERAL PARALAW

(Article V takes priority when charging suspects behind the Veil with crimes)

PENALTIES ASSOCIATED WITH ARTICLE VI

(Note that all penalties in Article VI come with a mandatory full amnestication of the anomalous world if the suspect is not operating behind the veil)

§ 6.1 - 5-10 years incarceration + full amnestication of the anomalous world

§ 6.2 - 5-10 years incarceration

§ 6.3 - 5-20 years incarceration

§ 6.4 - 5-15 years incarceration
