GENERAL BEHAVIOR EXPECTATIONS

Parent/Camper - Please read before signing above:

While attending the IL FFA Leadership Camp, which is managed by the Illinois Association FFA, there are certain behavioral expectations that must be observed by all participants to maintain good standing with FFA and participation in these programs. All participants in an event or activity sponsored by FFA are prohibited from involvement in unsafe, irresponsible, and/or illegal conduct. You are prohibited from consuming alcoholic beverages. In addition, you must abide by all rules and regulations established by FFA for participation in the 2020 IL FFA Leadership Camp.

1. In exchange for myself/my child or ward promises that my attitude, conduct and appearance will be such to reflect credit on my chapter, school, community, and state FFA association.
2. In exchange for myself/my child or ward promises to abide by the National FFA Code of Ethics.
3. Participant/Parent/Legal Guardian Only - In exchange for myself/my child or ward will not be in a cabin of another participant of the opposite sex. Failure to abide by this rule will result in immediate dismissal from the FFA Leadership Camp and my parent(s)/guardian(s) will be notified.
4. I/my child or ward will not use drugs, alcohol, or tobacco at any time during the FFA Leadership Camp.

Participant/Parent/Legal Guardian - I understand if myself/my child or ward violate this rule, the participant will be sent home immediately at my own expense and my parent(s)/guardian(s) will be notified.

Video/Photo and Release of Pictures-Videos/Audio/ Consent: In exchange for myself/my child or ward being allowed to participate in the FFA Leadership Camp sponsored by the Illinois Association FFA and as the custodial parent(s) or legal guardian(s) of the above-named individual, I/we verify that I/we fully understand, agree to, and accept all provisions and obligations set forth in this Video/Photo and Release of Pictures/Audio Consent Form.

PARTICIPANT PERSONAL CONDUCT AGREEMENT

In exchange for my being allowed to participate in the Illinois FFA Leadership Camp sponsored by the Illinois Association FFA, I, and my parent(s) or legal guardian(s) (individually and collectively referred to below in the first person singular) agree to be bound by the behavioral expectations set forth above and each of the following.

1. I agree to participate in the IL FFA Leadership Camp according to the guidelines set forth in this Personal Conduct Agreement and other applicable FFA publications.
2. I understand that Illinois Association FFA reserves the right and I agree that Illinois Association FFA has the right to immediately terminate my participation in the trip at the sole discretion of Illinois Association FFA, through its representatives, if I (a) engage in behavior that is unsafe, irresponsible, illegal, or otherwise contrary to FFA policy as expressed above or (b) consume alcohol.
3. I further understand and agree that if my participation in the camp is terminated pursuant to the preceding paragraph, (a) I will be solely responsible for all costs associated with my early termination, including my travel expenses, and (b) I will not be entitled to any refund of money I have paid to FFA for my participation in the FFA Leadership Camp.
4. I agree to allow FFA and its representatives to make reasonable, unannounced searches of my living quarters and personal belongings if FFA reasonably suspects that I am violating the behavioral expectations set forth in this Agreement and other applicable FFA publications.
