## ST. ANN PARISH COUNCIL MEETING -- JUNE 8, 2023

Meeting opened with prayer at 6:30 PM.

## FR. COREY COMMENTS:

- New officers were elected at the last KC meeting:
  - o Recorder Bob Koskinen
  - o Treasurer Wayne Schwartz
  - o Deputy Grand Knight Nick Lindeman
  - Grand Knight Jeremy Francois
- Totus Tuus will be here June 26 thru June 30. Many volunteers are needed and Karen (Sec'y) is making contacts.
- At last count approximately 1400 have signed up for the Eucharistic Congress.
- The altar server picnic will be at Gabes on August 9.
- The annual boys youth camping event is one-half full.
- The sign-up for the girls camping week is now open.

#### OLD BUSINESS:

- Rectory Roof Project
  - o Insurance Company has accepted the bid from Mark Koski.
  - o The shingles will match those on the Church roof.
  - The installation has not been scheduled yet.
  - Louis will be checking the cause of the leak into the downstairs bathroom and patching. Tony will be on hand when Louis goes on the roof.
  - Church Door replacement
    - o The approach pad to the door needs a bit of lowering − ¼ to ½ inch in various spots. This will be done by a work bee.
    - O Greg has been leading this project and has provide the PC members with many options to review and comment. After discussion the PC agreed on: A 36-inch single door which opens out / with 2 side lites / full glass / the door will hinge on the right looking from outside / Bronze finish / Standard 2 X 4 framework / standard matching hardware. The members (with input from Fr. Corey) agreed on a first and second choice of etching on the door and side lites. Greg will proceed to final agreement and scheduling with the contractor.
  - Parking Lot Apron
    - o No action on this project to date -- Todd will make contacts next week.
  - Proposed Bonus for Maintenance Person

- After discussion there was a Motion made by Richard with Second by Tony to provide a bonus of up to \$500 the final amount to be dependent on availability of funds at year end.
- FY 23 24 Budget Preliminaries --- Greg
  - FY ending June 30, 2023 was a financially good year with an ending surplus of \$7K and having added \$11,147 to the Investment Pool.
  - o For FY beginning July 1, 2023 the financial picture is much tighter.
  - Based on most recent trends, both loose and envelope collections are expected to be below the levels of the past year.
  - There will likely be no contribution to the Investment Pool as most costs are substantially higher than the past year.
  - Priest and Staff salaries will be increased by 2%. The Priest increase is mandated by the Diocese.
  - Hunter Supper proceeds will be allocated directly to the Building and Renovation Fund rather into General Income.
  - Many projects designated by the Parish Council will be directly budgeted rather than taken from the Building and Renovation Fund.

# FINANCE -- Greg

- The checking account balance is at \$37,600.58. Ladies Guild balance is currently \$5,470.02. The Investment Pool and Building and Renovation Account balances are unchanged from last month.
  - Motion to approve the finance report by Tony with second by Richard. All approved.

# SACRED HEART SCHOOL FINANCE -- Kathy

- The annual raffle may become a 50/50 event this year due to slow ticket sales.
- Some aspects of the proposed next FY budget:
  - All personnel would get 4% wage/salary increases
  - Projected enrollment is 60 students -- now have 54 enrolled for next vear.
  - Income from the 2 investment pools will likely be less than recent past years.
- A committee to target specific people for contributions to SHS is being voluntarily headed by a professional fund raiser.
