- 1. Diversity Equity and Inclusion Report 2021
 - a. Sent out to the TC Community Juneteenth of 2022
 - **b.** Feedback
 - **c.** Amelia Jones: Noticed the theme of initiatives geared towards admin, but not proactive when it comes to students. How can we support DEI within the student body?
 - **d.** Gabby Lamanno: Application of some of these main issues. We do all of this research but have seen little to nothing. How will this be applicable at TC?
 - **e.** Marion: Would like to get a fresh perspective about what DEI needs we have.
 - **f.** Tina Lee: I agree with Senator Lamanno. Lack of recommendations. Very bare minimum. There have been no proactive steps. Eboard was thinking about doing a townhall and senate can mediate and have faculty come as well. Lack of representation is an issue when it comes to students.
 - **g.** Krystina Heidelberg: Basics are being barely covered. We need action steps and long-term planning. We are getting "here are some facts" but no steps when it comes to what we can and should achieve.

 - i. Cameron Arnzen Is there a payscale for all positions at CU or affiliate schools?
 - ➤ GL: Not everything is transparent, discussion based model and is made in the application and interview process. 18-25, depends on what you are fulfilling. Less structure than work-study positions
 - ii. Marion Bakhoya: How are we defining "students"?
 - > GL: Students that are enrolled in the program and receiving credits
 - ➤ MB: Is that defined in the legislation?
 - ➤ NP: No
 - > GL: Not sure where to put it in the document
 - iii. Krystina Heidelberg: Exclusive to GAs, TAs?
 - ➤ GL: Anyone enrolled in TC across all positions, should be all roles.
 - > JS: Everyone taking a class or people who matriculated into a program?
 - Denise: There is a lot of work the college has to do to define who is a true student and a true employee. When it comes to wages, it is a good point but I don't know if this needs to limit your legislation
 - ➤ MB: For faculty, do they go through the faculty executive committee? What about students?
 - DB: FWS positions, Administrative Fellows (AF), Research Assistants (RAs), Graduate Assistants (GAs), Course Assistants (CAs), Doctoral Research Fellows (DRFs)
 - a. Interim positions (multiple titles associated with the pay code) are where students or others (non-students) can be appointed to hourly positions (below part-time hour requirements) and harder to account for
 - ➤ GL: We will clarify what students are in this resolution.
 - > NP: Will clarify who is a student regardless of credit.
 - iv. Cameron Arnzen Have you considered the basic trade off with higher wages versus the number of positions?
 - ➤ GL: Thinking about it as, given our current economy, you can't efficiently live on \$16 an hour. Everyone employed would more likely understand. A lot of federal work study jobs but it would benefit the people working those jobs

- ➤ NP: There is no information right now to even say there are enough positions to the number of students that can apply for these institutional positions. Is there data on the number of jobs and the number of students applying?
- TL: Maybe we look into the board's raises
- ➤ GL: As TC, if other affiliate schools are getting paid more than master students, there is an issue. They have less degrees than master students. If we are affiliates, we should have similar erules when it comes to work and pay,m especially if other schools are adequately paying their students and we are not
- ➤ MB: How do you plan to highlight the fact that we are an affiliate and our endowment isn't as large as the other schools?
- ➤ NP: Assistantships are based on the department and there is an awareness of how many funds are available
- ➤ GL: Federal work-study, they are not funded by the institution by the federal government, my assumption that the federal government can have that discussion with TC. There is a discrepancy about why TC is structured at \$16 when other institutions can go up to \$20.50. Work study isn't coming from the institution raising money
- ➤ Denise: Point of information. Specification of the legislation. More strategic to talk to federal work study and college budget since they are 2 different VPs.
- ➤ KH: If wages are raised higher in work study, would it affect their maximum amount per semester?
- > GL: You would need to request more money.
- ➤ KH: Maybe that's information that we could add into the legislation.
- ➤ GL: Something we can include, but that exceeds what we are advocating for right now. Difference between work study and other employees. Once we get adequate wage, there is no point in getting that process written down unless we can't get the increase in wages passed
- ➤ MB: Are there any short term goals, or small wins you can identify?
- ➤ NP: Increase in wage
- ➤ MB: Anything within the next 3 months you can identify that we can accomplish?
- ➤ NP: As of now, an acknowledgement that this is something they are working on and including a timeline
- GL: Getting involved in the process and discussion and decision process about pay
- ➤ MB: Is this something that's being worked on?
- ➤ Denise: Student Employment Committee that was formed last year put together a proposal, and the group did touch on increasing and standardizing wages. The proposal did bring forth a full-time position for someone in TC NEXT to specifically focus on student employment, and just received word today that the position has been filled! Recommend that the Senators working on the legsilation connect with Laura Coleman who chaired the committee and will be leading the student employment area in TC NEXT. The Financial Aid Committee, that meets monthly as of this calendar year, has touched

- on funding opportunities linked to FWS and employment but focused more on overall funding packages. That committee is being led by Tani Castañeda.
- ➤ MB: Is there a student on the committee?
- ➤ Denise: Cam and Marion are pushing for more student voices. Once committee feels more secure, the committee will reach out to Cam and Marion to include more students

OLD BUSINESS:

- 1. Legislation Process Overview Continuation from 10.24.22
 - a. Next steps in Legislative Process
 - i. Next general session we will have a discussion about this legislation, then we will vote, unless a tabling or something else will occur. Next committee meeting would be important to come to a consensus about the legislation as a committee. If passed, the legislation will go to the president and she will either sign or veto
 - ii. MB: We are actively working on getting the legislation in front of the right people to ensure your hard work is being showcased and pushed for
