A BILL

To establish Assembly Districts in the Republic of Fremont.

Be it enacted by the people of the Republic of Fremont,

Section I. SHORT TITLE

(a) Short Title.—This Act may be cited as the "Fremont Assembly Districts Act"

Section II. FINDINGS

The Fremont Assembly finds that—

- (a) Members of the Assembly of the Republic of Fremont currently represent the state at large and have no geographic constituency, increasing constituent services costs on the part of assembly members.
- (b) Citizens of the Republic of Fremont lack a geographically specific representative in the Assembly, which has led to localized issues being ignored in the halls of the Assembly, hampering the possible consideration of issues not relevant to the entire Republic.
- (c) No law nor the Constitution expressly prevents the Assembly from dividing itself into districts of which assembly members will represent.
- (d) The Equal Protection Clause of the Fourteenth Amendment to the United States Constitution provides for equal representation, in effect requiring relatively equal district populations.
- (e) By dividing the Assembly into districts of relatively equal populations from the former federal congressional districts of the state prior to its foundation, said districts can fulfill the requirements of the Equal Protection Clause of the Fourteenth Amendment.

Section IV. AMENDMENT TO THE FREMONT CODE TO ESTABLISH ASSEMBLY DISTRICTS.



Section V. TECHNICAL AMENDMENT TO ARTICLE 1.

Section VI. REPEAL OF REDISTRICTING PROCEDURES.

[Title 2, Division 1, Chapter 3.2 of the Fremont (California) Government Code](article=2.&part=&chapter=3.2.&article=) shall be repealed.

Section VII. APPROPRIATIONS FOR DISTRICT REPRESENTATION.

For the purposes of implementing district-based representation in the State Assembly and ensuring a smooth introduction of productive constituent service operations, no less than \$5,000,000 shall be appropriated for each member of the Assembly, \$35,000,000 in total, from item (a) authorized in Section 202, "Legislative, Judicial, Executive, Government Operations", of [WSB-01-72, the Consolidated Revenue and Appropriations Act of 2021.](https://docs.google.com/document/d/1bshswO0kokVQjNESdQpZ Xy 1wLw 5-NgOKJ9oEBxrEY/edit)

Section VII. ENACTMENT.

This Act shall come into effect immediately upon enactment.
