- Attach the online link to supporting materials directly into this form.


Judging Process & Timeline:

- Top 18 finalists (3 LEs & 3 SMEs per category) will deliver live pitches at the GBA Business Awards Night 2025 and proudly represent GBA at the EuroCham Business Awards 2025 in October.
- Top 6 Winners (1 LE & 1 SME per category) will be chosen through a combination of jury selection and live voting on Pitch Day. They will be officially crowned as the GBA Business Awards 2025 winners and will go on to proudly represent GBA at the EuroCham Business Awards in October.
