

Workshop #6 on Violence against Women and Girls **18 November (14.00-15.30 CEST)**

Intro

In the framework of the 15th anniversary of the [European Charter for Equality between Women and Men in Local Life](#), CEMR is organising a series of workshops to reflect together on how the Charter could be improved.

This workshop will focus on [articles 21, 22 and 23 of the Charter](#), which address violence against women and girls:

- Article 21: *"Safety and Security"*
- Article 22: *"Gender-Based Violence"*
- Article 23: *"Human Trafficking"*

Together, participants will have a chance to exchange on the challenges they face in implementing these articles and share their experience on what practices have worked--or not--in order to establish recommendations based on field experience.

This will also be the occasion to replace any outdated information and brainstorm on new ideas that could be included to strengthen the Charter and its relevance for Europe's local and regional governments (LRGs). These series of discussion workshops will culminate in a final report with recommendations for actions to update the Charter and its tools in 2022-2023.

Aims

- Help signatories reconnect with the Charter by engaging a dialogue about the text
- Understand how the Charter has been interpreted/implemented by the signatories
- Gather opinions on the current state of the group of articles
- Brainstorm on possible improvements of the group of articles and come up with recommendations
