INTRODUCTION

Articles written in the journal SITEKNIK include research results and study results in the field of information systems, engineering and applied technology in general. Articles are written in English. The manuscript is typed on A4 paper, with Times New Roman font model, size 12 pt, with space 1 (*single*). The distance between the top margin is 1 cm, the bottom is 1 cm, the left is 3 cm and the right is 3 cm. The number of pages is a minimum of 8 and a maximum of 10 for each article. The maximum **plagiarism** in each article submitted is **15%** in accordance with the provisions of our journal. The writing of the title of the introduction is written in capital letters of all font sizes of 12 pt, as well as methods, results and discussions, conclusions and suggestions, acknowledgments and references. The presentation of the introduction is carried out narratively in the form of paragraphs or paragraphs and does not need to be separated from one subsection to another. Separation is done only by the change of paragraphs. The content of the introduction includes the background, a summary of the literature review, and ends with the purpose of the research. The introduction contains a description of the background, research objectives, newness of the research, research benefits, methods used, and the results of the benefits of the research. The introduction is written clearly, sequentially and in easy-to-understand language. The author is expected to be able to convey the results of research that has been carried out by others as a reinforcement of research in this article. In addition, it is hoped that the author conveys what is the research question and the gap between the current research and the previous research. The last paragraph or paragraph in the introduction is expected to be a statement of the main purpose of the research. Authors are not allowed to include any tables or figures in the introduction (Purnomo et al., 2021).

RESEARCH METHODS

The method is clearly described which contains a variety of content such as design, population and sampling techniques, research methods and flows, observed parameters, and technical analysis. The written method is conveyed with a narrative in the form of paragraphs or paragraphs by conveying the importance of how the research is conducted. Any form of instruction or technical manual in research activities that is too detailed should not be included.

RESULTS AND DISCUSSION

The results and discussion section contains the results of data analysis (not raw data). Presentation can be assisted by tables or graphs in the form of pictures and must be accompanied by explanations or giving meaning of the analysis results. Then the discussion contains a discussion of the results of research on previous research, theories, or established knowledge, accompanied by references. The results of the study can be supported, unsupported, or even contradictory.

Sub Chapter Results and Discussion

The author is expected to be able to interpret the results of his research and then connect it with other journals in the form of clear sources (accompanied by scientific discussions and supporting arguments). The discussion must be able to align with the main objectives of the research in the Introduction. The author can include tables or graphs in the form of images in the research results.

Table Presentation

The caption or table title is written in Times New Roman font size 12 pt, thick (**B**) and placed above the table, the position of the table title text in the middle with the format as seen in example table 1. Each table title should use a sequential number (such as: "Table 1, Table 2") typed with a space and followed by a period(.). Fill in the table using Times New Roman font with a font size of 10 pt. The table title shows the table description of "what", "where", "when". If the table is derived from a citation, then the source of the data or information is written and placed under the table with the Times New Roman font 10 pt position in the middle. Table titles and table contents must not be truncated and must be made into one page, must not exceed margins. If the table must contain a large amount of data, then it is welcome to connect to the next page but

must display the same table description as on the previous page. As shown in table 1 and table 2.

Image Presentation

The image is placed in the middle of the column one single space away from the paragraph. If the size of the image exceeds the width of the kolom, the image can be placed in a single-column format. Images can be placed after or before designations in the script. The images are given a number or number sequence. The name of the image is placed below the image and is one single space away from the image. The name of the picture is written using Times New Roman letters with a font size of 12 pt, bold. The image of the reference result must be accompanied by the source (Source: author's name, year). Images should be legible to read, and can be printed in good quality in color. If it is a black and white image, make sure that it can be printed clearly, as shown in figure 1.

The acknowledgments section can mention the source of funding from the person who funded the research, or the name of the institution/person who helped with our research.
