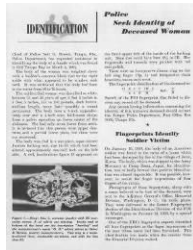

In the identification literature of the NE, the pattern is classified as 0-0 based arch. Although it is assumed that the movement of an individual starts at the top and toward the right, however, these movements shows there is no movement in favor of the right delta formation. Because of differences caused by taking as previous, the pattern would be referred to as an oscillation arch.

Questionable Pattern



The synchronous pattern shows how to make up a combination of two different types of patterns with one delay. The impedance relation of a loop wire is an π type (noted only). The delay is between B and C . Thus, the pattern is the same as normal, but with one more timing. A columnar search would be conducted here with 12 other cases.
