## **TERMS OF AGREEMENT:**

- 1. Provide Certificate of Insurance equal to amount carried by the Wilhelm Tell Guild (\$500,000.00). For further information contact Mosher & Associates, (608) 527-2151.
- 2. Rental fee for the use of the property shall be a daily rate of \$100.00, a weekend rate (Fri-Sun) of \$250.00, and a weekly rate of \$500.00. Rental fee shall be required upon approval of the rental agreement by the Wilhelm Tell Community Guild. Rental fee must be received within 10 business days of approval. If not received, rental agreement shall be terminated.
- 3. Security Deposit (separate from the rental fee) of \$250.00 shall be required upon approval of the rental agreement by the Wilhelm Tell Community Guild. Security deposit will be refunded if cleanup is done and there is no damage to grounds or property. Security deposit must be received within 10 business days of approval. If not received, rental agreement shall be terminated. At the completion of the event, if there are no damages to grounds/property and cleanup has been completed, the Tell Guild will return the security deposit within 10 business days.

- 4. Refund requests can be submitted in writing or by phone. Any refund that is requested less than 14 days prior to the event will receive a 50% refund. Any request more than 14 days prior to the event will receive a 100% refund.
- 5. There are 8 round tables available for use at the Shooting Park. Chairs are also available. Tables and chairs must be returned to the same location as when rental began.
- 6. Garbage must be removed by renter or contracted service.
- 7. Renters must clean the facility prior to use and after.
- 8. Alcohol is allowed when offered by renter provided it is a 'closed' event (not open to the public).

  Other questions regarding selling of alcohol should be directed to Wilhelm Tell Community Guild.
- 9. Smoking is not permitted inside the Schutzenhaus (Shooting Barn). Ashtrays/receptacles must be provided and removed after event.
- 10. Illegal substances and unsafe activities are NOT allowed.
- 11. Electricity is available.
- 12. There is NOT POTABLE water at either location.
- 13. Two (2) Large upright floor fans are available and must be returned to there prior location at the completion of the event.
- 14. Two (2) Large upright propane heaters are available. Renter must provide the propane.
- 15. Renters are responsible for the premises during the rental period.
- 16. Be Aware: There are resident bats. Take this into consideration after cleaning and prior to your event
- 17. Renters are responsible for any damage. This may be deducted from your security deposit unless there is a greater amount of damage done above and beyond the \$250.00 deposit and is not covered by renter's insurance.
