MCHHSA 501c3 Update: Report from Paul Prokosch, Mille Lacs County

All requirements for acquiring 501c3 status have been completed. Articles of Incorporation have been filed and accepted by the state and we have received our Federal Tax Identification Number from the federal government.

Regional Meetings:

Peggy Koscielniak, Benton County asked for thoughts on continuing to hold separate Regional Meetings or possibly creating a quarterly statewide meeting in St Cloud. Benefits of the statewide meeting would be that state staff would only have to travel to one location and counties could possibly save on expenses related to meetings. After discussion, it was determined that regions would continue to host Regional Meetings on their own and the Regional Meetings would be opened up to all when appropriate content was on the agenda.
