7.1.1. Section 2 - Game Procedure

2.a - Be amended as follows:

Start times will be determined by the Athletics Consultant.

2.b. - Be amended as follows:

A game will consist of:

One - 20-minute straight time development quarter (10 plays for each offense).

Four - 15-minute straight time quarters.

2.c - be amended as follows:

Strike two; replace with three (3).

7.1.3. Section 7 - Rules and Regulations

Be it resolved that the Cheer and Dance Sport Policy be amended as follows:

7.5.1 Section 6.a - Tie Breaking Procedures - add the following:

At all SSSAD-sanctioned Cheer and Dance events, SCA Tie-Breaking Procedures will be used in the event of a tie. It is the responsibility of all participating teams and coaches to review and understand these procedures prior to competition.

4.d.i SSSAD has adopted the SCA Video Review Challenge process. The

SCA processes are applicable to all SSSAD-sanctioned Cheer and Dance Competitions.

Please note:

4.d.ii. Only head coaches can submit a challenge.

4.d.ii.1. All coaches must be familiar with the SCA Video Review Challenge guidelines prior to the event.

4.d.ii.2 Questions about the process must be directed to the event organizer or head judge before the start of competition.

4.d.iii. Challenges may only be submitted by teams participating in the specific division and session in question.

4.d.iv. All challenges must be received in writing within 10 minutes of receiving their score. Late applications will NOT be accepted under any circumstances.

4.d.iv.1. Complete a Video Review Challenge Form (available from the event director or scoring table).

4.d.iv.2. Only official event video footage will be used. Personal or team footage will not be accepted.

4.d.v. The host school provides all equipment and personnel necessary to conduct a video review. Included but not limited to:

4.d.v.1. All video and computer equipment including operating personnel.

4.d.v.2. Video Review Challenge Forms.

4.d.vi. The judge's decision is final and binding with no further appeals allowed.

4.d.vii. If an error is confirmed, scores will be corrected and standings updated accordingly.

7.6.1 Section 5.b.i. League Championship Scoring System - replace with:

5.b. i. Individual Event Points (Per Mini-Meet)

Athletes earn points for their school based on placement in each event, following the same scoring system as provincials:

Place	Points	Place	Points
1st	18	9th	8
2nd	16	10th	7
3rd	14	11th	6
4th	13	12th	5
5th	12	13th	4
6th	11	14th	3

7th	10	15th	2
8th	9	16th	1

- A maximum of four athletes per school can score points in any individual event.
- A maximum of two relay teams per school per relay category (e.g., Junior Boys 4x100m) may score points.

After all individual and relay event points are totaled for each school at a mini-meet, team rankings are determined. Based on these rankings, schools earn League Standing Points as follows:

Team Rank	League Points
1st	10
2nd	8
3rd	6
4th	5
5th	4
6th	3
7th	2
8th	1
