

Tenets of Adult & Minor Vocal Synthesis Space Interaction

Preface

These are a set of tenets designed to protect both minors and adults within the online vocal synthesis community. The purpose of this document is to establish a community-acknowledged standard to help regulate interactions and prevent harmful behavior. This will help stop grooming attempts at their roots and offer a framework for examining and addressing allegations. It will also help the community at large, both adult and minor, feel safer, having more confidence in expressing themselves online while making new connections.

The goal is not to police the community, but to offer guidance and education. By keeping these tenets in mind, you can use them for better judgement in your online relations. If a violation is found, you can address it with that individual and share this document to help them out. However, if you feel uncomfortable, you are always within your right to disengage- and if the violation is serious, use the block button.

These guidelines may be adapted over time, but will ultimately be reviewed and approved by a group of trusted adults in the community. Anyone with editorial control over this document, including its creator, may lose that access if they engage in behavior toward a minor that is widely recognized as grooming.

Tenets

1. Establish Clear Boundaries

Both minors and adults must set clear boundaries in regard to what they are comfortable discussing and how they'd prefer to interact. NSFW topics are completely off-limits in any interaction with a minor.

2. Maturity Is Key

Interactions between adults and minors under 15 should be kept to an absolute minimum. At that age, most minors lack the maturity to view adult connections in a healthy, balanced way with their current level of development. Conversation with a minor under 15 years of age should be discouraged.

3. Separation of Adult Content

Adults in the community must keep all NSFW or 18+ content on a separate account. This applies regardless of whether the content is IRL or animated.

- These accounts should be clearly labeled as adults-only in their bios.
- NSFW content accounts should be shared only with other adults and in secure spaces.

- When a minor becomes 18, or if an adult decides they want to have an 18+ online presence, they need to make a separate account rather than turn their minor-friendly one into an 18+ one.

4. Appropriate Labeling

Adults who maintain a separate account for adult content must:

- Clearly label NSFW posts using the platform's corresponding tools.
- Ensure their 18+ username is distinct enough from their SFW username to make discovery by minors less likely

Ex: "JaimesHumps" is less discoverable than "JaimeSynthNSFW." (Example only)

5. No Searching for NSFW by Minors

Minors must not seek out NSFW content related to adult vocal synthesis creators. It's natural to want to explore when trying to understand yourself and your attraction, but interacting with adult creators' NSFW material, even if unintentional, can lead to distress for both parties.

6. No Sharing of Personal Details

Adults and minors must not share excessive personal life details with each other. This kind of exchange can easily create a power imbalance and be used for manipulation whether it be intentional or not.
