RULES:

- If your Terms of Use or Terms of Service invalidates any of my rules, do not contact me for a commission.
- That being said, this is a declaration that my terms and conditions overrules any conflicting terms in the commissioners personal Terms of Use regarding my artwork.
- But contacting me for commissions means you automatically accept these terms and will be fully responsible should you break them.
- I do **NOT** draw for:
 - Exposure (Shoutouts, Advertisements, Credit)
 - Delayed payments
 - Work to be use for NFT purposes
 - Work to be fed to Al
- I retain the copyright to my work and require attribution / credit in any post.
- I require a minimum of 50% of the payment once a rough sketch is agreed upon at the latest.
- Work In Progress images will be sent for critique. I will not do MAJOR CHANGES beyond the rough sketch phase.
- $^{\circ}$ MINOR CHANGES: Changing the colours/ small details/ accessories/ eye/mouth positioning/ etc.
 - MAJOR CHANGES: Changing the pose/ character/ outfit/ hairstyle/ etc.
- A heavily watermarked proof of the final product will be sent, and the remaining amount is to be sent before the watermarks can be removed.
- Visual reference is preferred, and as much detail as can be provided to receive the most out of my artwork.
- I accept payments through PAYPAL, STRIPE and KO-FI in GBP.
- My artwork is not for commercial use.

- o Commercial use means anything involving using a product or service for financial gain. For example, merchandise/ books/ advertisements/ apps/ etc.
- Unauthorised use of my work for commercial purposes will mean being blacklisted from ever being able to commission me again.
- Refunds will only be offered upon cancellation **PRIOR** to completion. I will not accept requests for refunds after the drawing is finalised and delivered.
- $^{\circ}$ You may only receive a 50% refund for commissions that have reached the <u>rendered</u> phase.
- Do not trace or heavily reference my work without permission.
- Do not remove watermarks from my work.
- I am free to use the commissioned work to promote myself unless specifically stated otherwise by the client.
- Please understand that I have the right to refuse a commission if I would like to.

COMMISSION PROCESS

- Once the client makes their request, I will work on a sketch when available. They will receive a rough sketch for feedback and approval. If the commission possesses several potential outcomes, I will provide them with multiple sketches for the client to choose from.
- A minimum 50% of the payment will be made after the rough sketch is agreed on (at the latest). The commission will be put on hold until I receive this payment. Payments should only be discussed privately.
- Delivery time of the commission varies on my availability. The client is free to ask for an estimate of completion for their commission. Should there be any delays, the client will be notified.
- The client is welcome to ask for updates on the artwork at any point throughout the process. I will update my Trello page regularly otherwise, if they would prefer to check there.
- Once the artwork is complete, I will send a watermarked version to the client as proof of completion. They will only receive the original version once I have received the other half of their payment.
- •The finished product will be delivered through a Google Drive folder, containing that and previous variations of the artwork should they want them.

I have the right to retain screenshots of the commission conversation as a protective system in the case of slanderous remarks. By contacting me, you automatically agree to my terms of service and will be held accountable should you break them. Penalties include: cancellations, the potential of no refund, blacklisting, and an artist's beware post. The refusal of refunds is only applicable if the commission experience is incredibly deplorable due to your behaviour. Understand that I am a human first, and artist second. I have the right to refuse to work with anyone who talks down to me, treats me poorly, makes me uncomfortable, or sexualises or objectifies me. If I choose to take a penalising action, I will send a courtesy message explaining what led to the cancellation and any other action. As a protective measure I will screenshot evidence and the courtesy message to justify slander.
