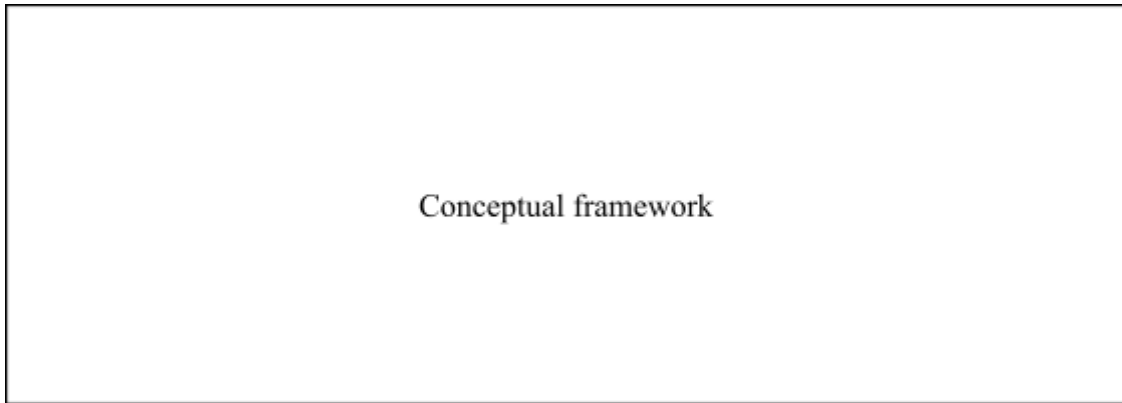


Figure 1 Conceptual framework

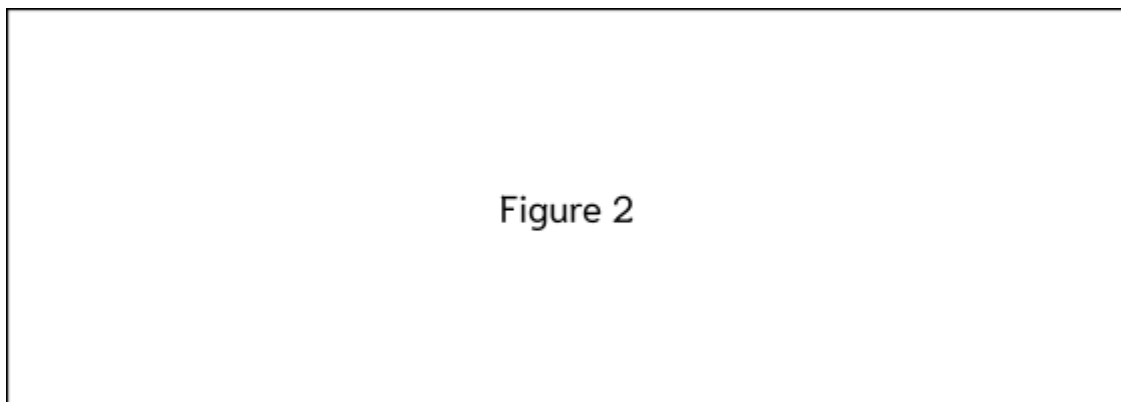
