# Privacy Policy

## Collected Information

When collecting non-personalized usage data, **Volume Up Plus** uses only domains or incomplete URLs that cannot be used to identify you. You can disable the transmission of usage data in the extension settings to limit data collection to only what is necessary for the extension to function.

**Volume Up Plus** does not collect or transfer cookies, passwords, email addresses, or any other personally identifiable information.

If you contact us, we may retain the personal information you voluntarily provide, such as your name and email address, solely for communication purposes. This information will be kept only for as long as necessary and will be securely deleted afterward.

- **tabs:** Required to manage audio playback across different tabs and ensure consistent functionality.

These permissions are used solely to enhance your experience and provide the features promised by **Volume Up Plus**. They are not used to collect personal data or compromise your privacy.
